Market Summary**Saudi Stock Exchange (Tadawul) – Annual Statistical Report - 2010**

Total Value of Shares Traded reached **SR 759,184.84 million** and **19.54 million** Transactions were executed during the year 2010

At the end of the year 2010 **Tadawul All Share Index (TASI)** closed at a level of **6,620.75** points compared to **6,121.76** points for the previous year, gained **498.99** points (**8.15%**). The highest close level for the index (TASI) during the year was **6,929.40** points as on **26th of April**.

The total **Market Capitalization** at the end of the year 2010 reached **SR 1,325.39 billion** (US\$ **353.44 billion**), increasing by **10.86%** as compared to the end of the previous year.

The total **Value of Shares Traded** for the year 2010 reached **SR 759.18 billion** (US\$ **202.45 billion**) compared to **SR 1,264.01 billion** (US\$ **337.07 billion**) for the previous year, a drop of **39.94%**.

The total number of **Transactions** executed during the year 2010 reached **19.54 million** compared to **36.46 million** trades for the previous year, decreasing by **46.42%**.

* The total number of **Shares Traded** for the year 2010 reached **33.01 billion** compared to **57.13 billion** shares traded during the previous year, decreasing by **42.22%**.

* **Historical prices & volume traded data are adjusted to account for all corporate actions during the year.**

- **Number of trading days during 2010 were 249 days, against 250 trading days during 2009.**

The **Daily Average Number of Transactions** executed during the year 2010 reached 78.46 thousand trades compared to 145.83 thousand trades during the previous year, decreasing by 46.20%.

The **Daily Average Value of Shares Traded** during the year 2010 reached SR 3,048.93 million compared to SR 5,056.05 million for the previous year, a drop of 39.70%.

The **Daily Average Number of Shares Traded** (adjusted) during the year 2010 reached 132.56 million shares compared to 228.52 million shares traded during the previous year, decreasing by 41.99%.

Sectoral Activities:

In term of **number of transactions** during the year 2010, the Insurance sector was the most active sector with 4.90 million trades that represent 25.10% of the total trades during the year, followed by the Petrochemical Industries sector with 3.87 million trades or 19.79% and the Industrial Investment sector 1.78 million trades or 9.10% of the total trades executed during the year 2010.

The Petrochemical Industries sector led the market in term of **value of shares traded** during the year 2010 amounting to SR 287.30 billion that represent 37.84% of the total value traded, followed by the Banks & Financial Services sector with SR 98.73 billion or 13.01% and the Insurance sector SR 90.35 billion or 11.90% of the total value traded during the year 2010.

In term of **volume of shares traded**, the Petrochemical Industries sector was the most active sector during the year 2010, the number of shares traded for the sector reached 9.51 billion shares that represent 28.80% of the total volume traded during the year, followed by the Banks & Financial Services sector with a volume of 5.87 billion shares or 17.79% and the Insurance sector with 3.11 billion shares traded or 9.42% of the total shares traded during the year 2010.

Stock Activities:

With respect to stocks activity during the year 2010, SABIC led the market in term of **number of transactions** with 837.16 thousand trades, followed by Alinma Bank and Saudi Kayan with 821.99 and 628.85 thousand transactions respectively.

SABIC was also the market leader in term of **value of shares traded** during the year 2010 and has posted a turnover of SR 98.23 billion. The two other most active stocks were Saudi Kayan and Alinma Bank that posted a value of SR 66.83 billion and SR 59.87 billion respectively.

In term of **number of shares traded** (adjusted) during the year 2010, Alinma Bank topped the list with **5.06** billion shares traded during the year, followed by Saudi Kayan and Zain KSA with a volume of **3.48** and **1.37** billion shares respectively.

Initial Public Offerings (IPOs) Summary - 2010

The number of companies offered parts of its shares to public (IPOs) reached **9** during the year 2010. These were **3** companies from the Insurance sector, **2** companies from the Industrial Investment sector and **1** company from the Cement, Agriculture & Food Industries, Building & Construction and Real Estate Development sectors, bringing the total number of listed companies to **146**.

The total offered value reached SR **3.83** billion and the number of shares offered for all IPOs during the year 2010 was **245.35** million shares.

By the end of the year 2010 the market capitalization of the IPOs companies reached SR **13.41** billion that represent **1.01%** of the total market capitalization.

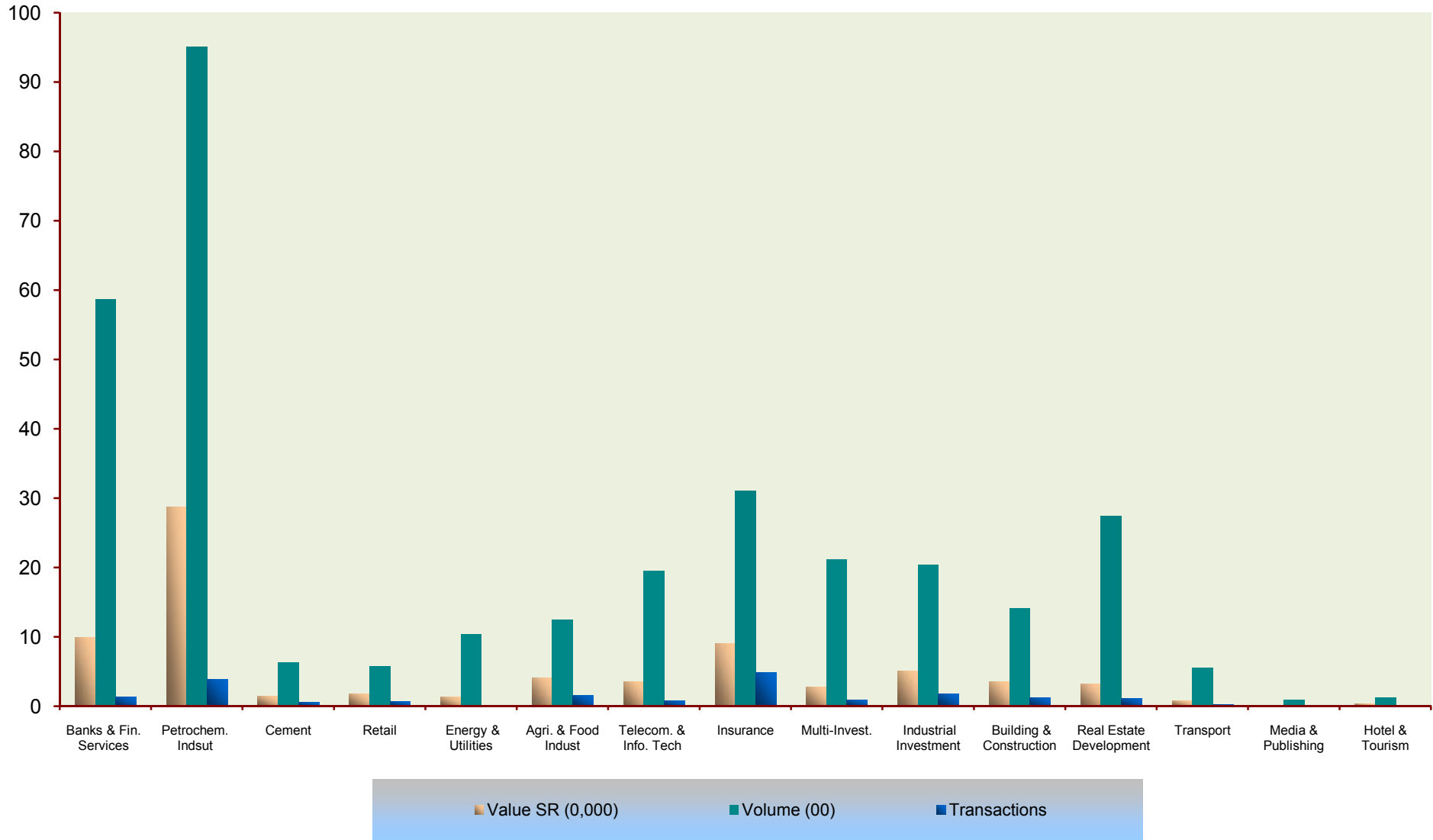

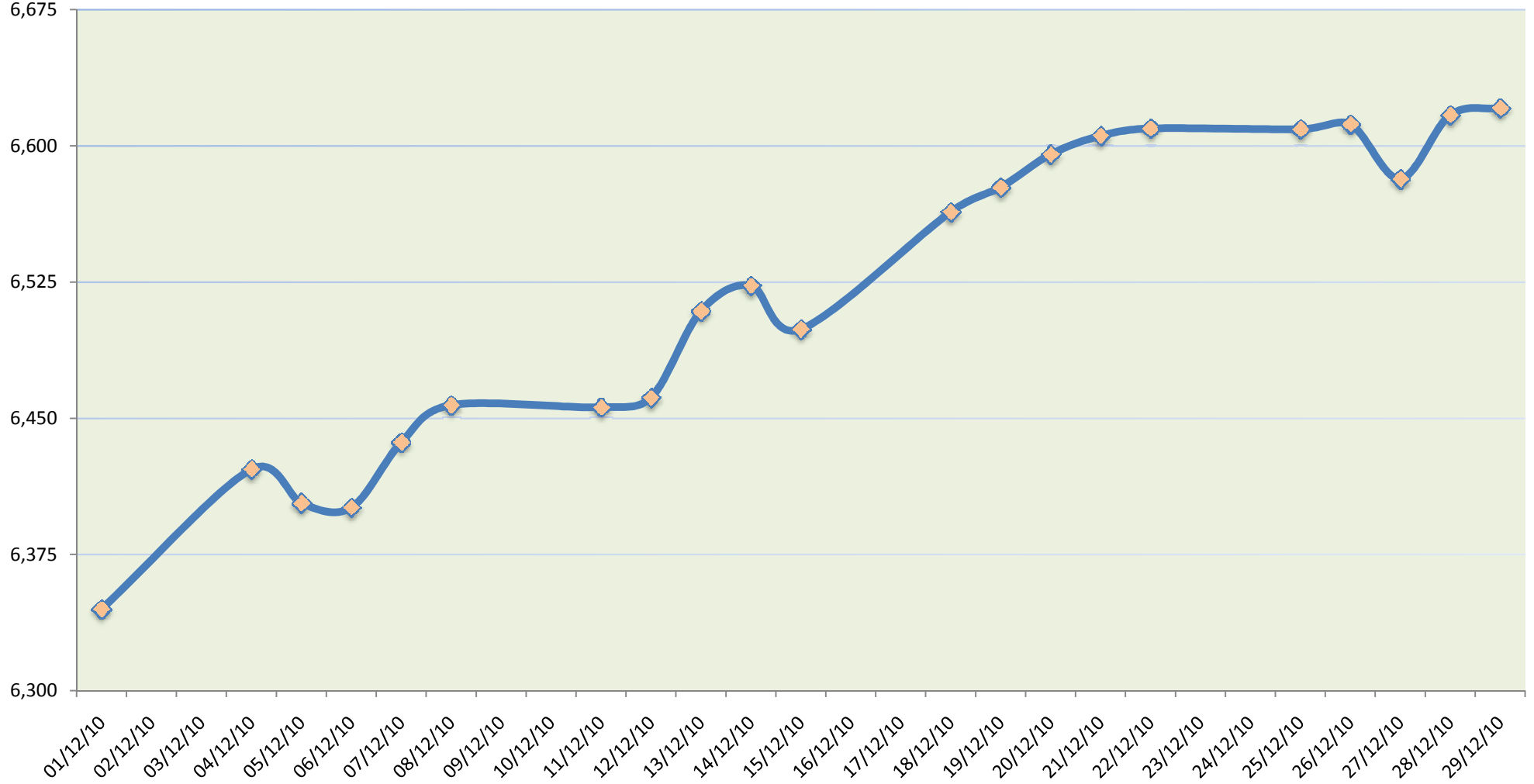

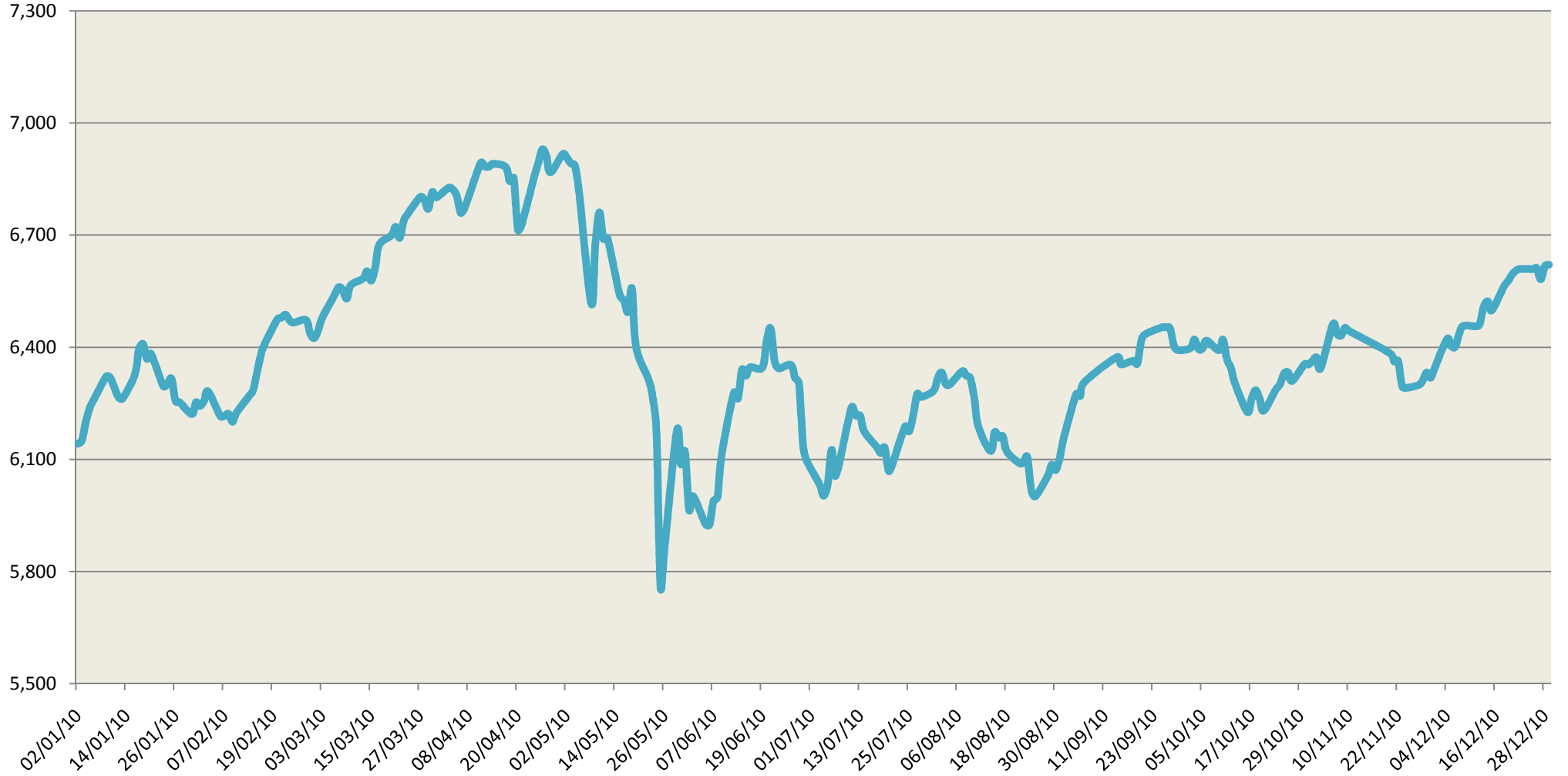
Tadawul All Share Index (TASI) - 4th Q 2010

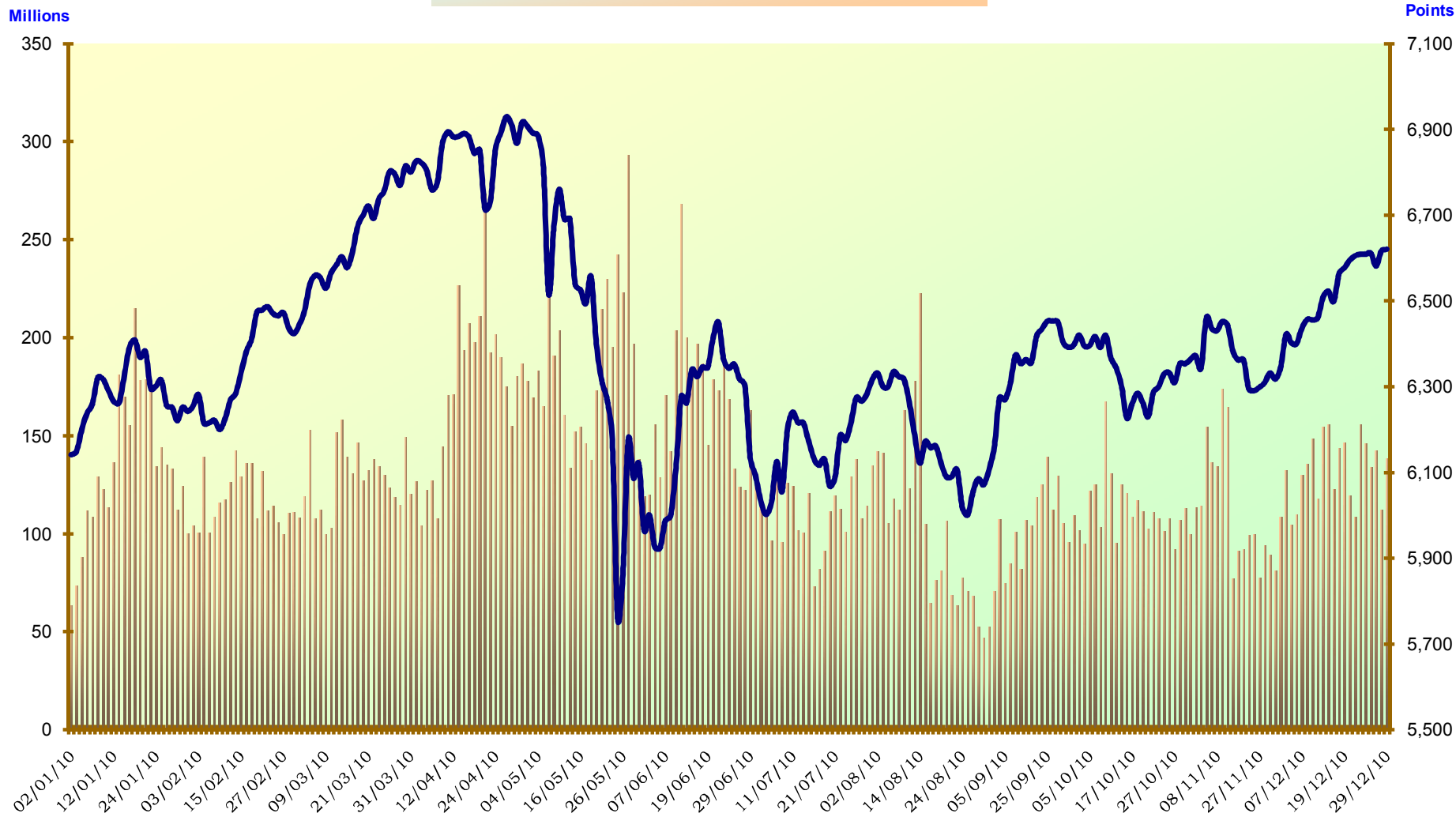


TAdawul All Share Index (TASI) - 2010

Points



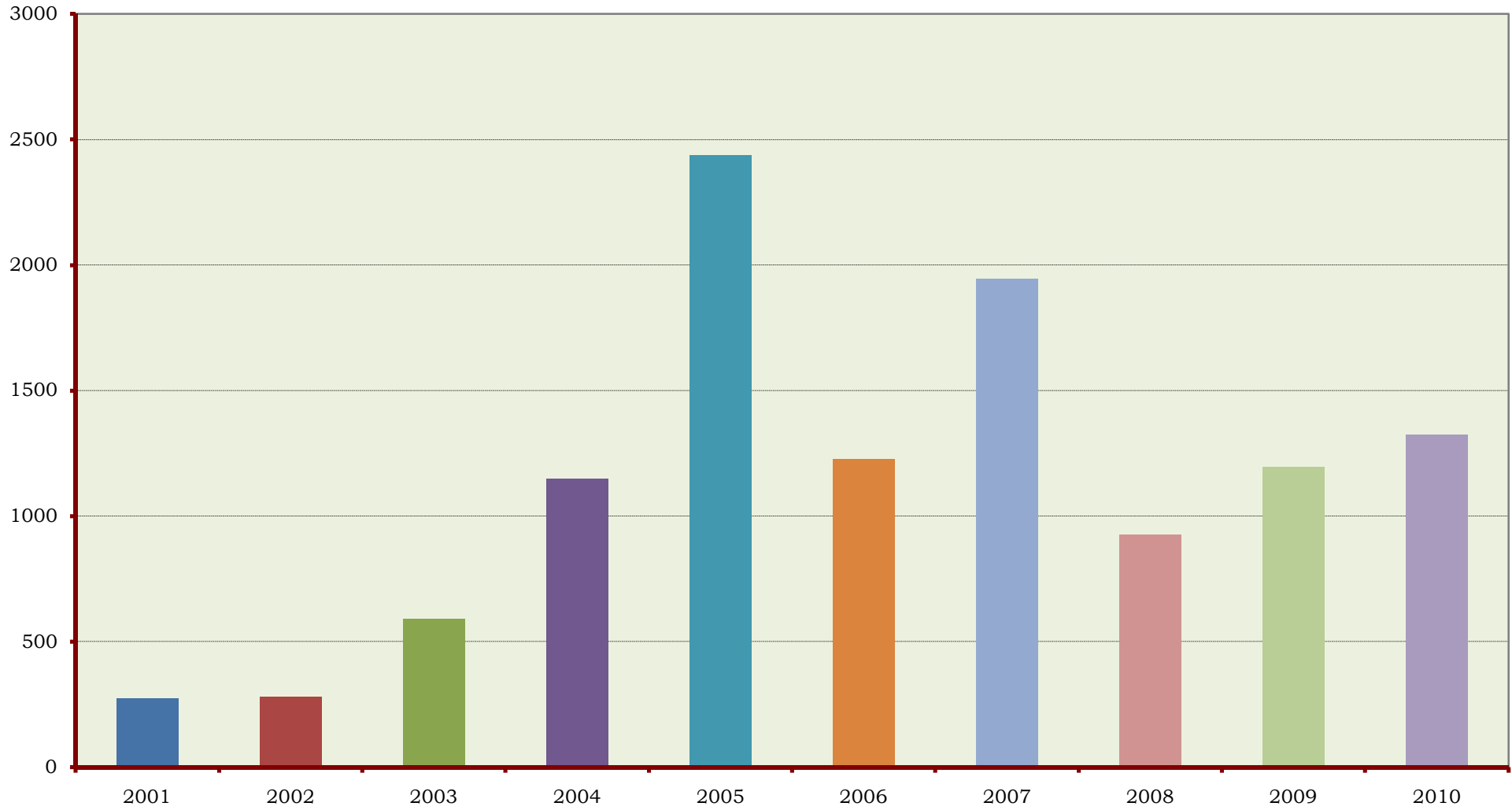
TASI & Volume Traded - 2010

Market Capitalization 2001 - 2010 (SR billion)

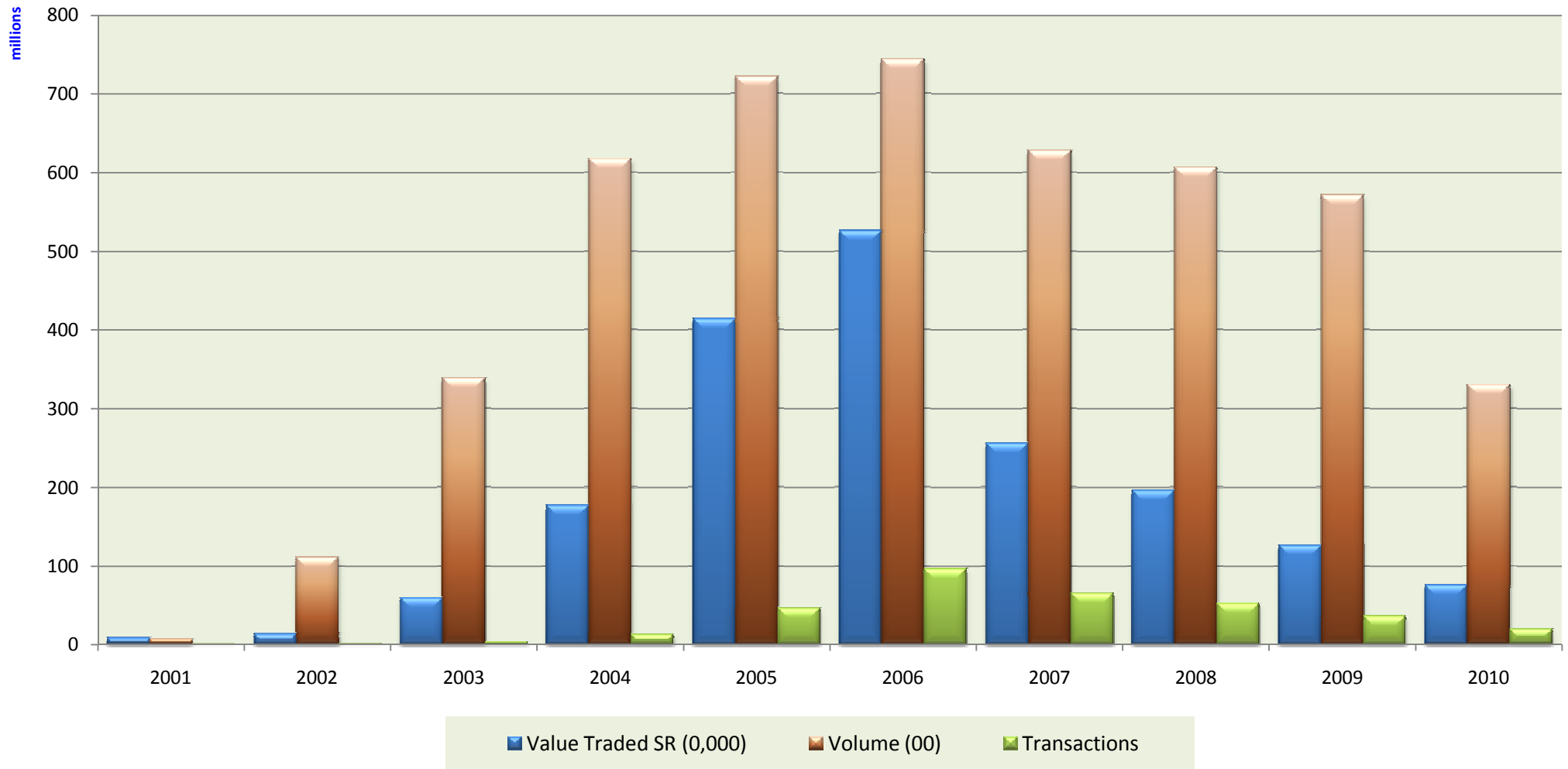
