#### **Highlights**



The total value of shares traded for the month ending 31 August 2015 amounted to SAR 116.28 billion, increasing by 37.76% over the previous month; while total stock market capitalization reached SAR 1,685.51 billion at the end of this period, decreasing by 16.37% over the previous month.

- The total value of shares purchased by "Saudi Investors" during this period amounted to SAR 110.49 billion representing 95.02% of total buying activity, and sales of SAR 110.38 billion representing 94.93% of total selling activity. Total ownership of "Saudi Investors" stood at 92.37% of total market capitalization as at 31 August 2015, representing a decrease of 0.004% from the previous month.
- The total value of shares purchased by "GCC Investors" during this period amounted to SAR 2.40 billion representing 2.06% of total buying activity, and sales of SAR 1.99 billion representing 1.71% of total selling activity. Total ownership of "GCC Investors" stood at 2.50% of total market capitalization as at 31 August 2015, representing a decrease of 0.09% from the previous month.
- The total value of shares purchased by "Foreign Investors" during this period amounted to SAR 3.40 billion representing 2.92% of total buying activity, and sales of SAR 3.91 billion representing 3.36% of total selling activity. Total ownership of "Foreign Investors" stood at 5.13% of total market capitalization as at 31 August 2015, representing an increase of 0.10% from the previous month.
