


	High Net Worth Investors (HNWIs)	HNWIs are Saudi individuals who have had an average portfolio size of SAR 1m (and above) for the preceding 12 months, excluding IPIs (see below).
	Individual Professional Investors (IPIs)	IPIs are Saudi individuals who have had an average portfolio size of SAR 50m (and above) for the preceding 12 months and a portfolio turnover ratio of not more than 4 times annually.
Saudi	Individual DPMs	Saudi individual investment account in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).
Sadai	Institutions	Saudi Institutions have been classified under 4 categories as defined below:
	Corporates	Saudi company with a commercial registration permitting its investment in the stock market .
	Mutual Funds	A mutual fund managed by an Authorized Person and licensed by the CMA.
	Government Related Entities (GREs)	A Government entity or a supranational authority recognized by the CMA.
	Institutional DPMs	Saudi institutional investment account in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).

GCC	Institutions	GCC legal person with a commercial registration certificate (corporate or mutual fund), in addition to GCC government entities.

	SWAP Holders	Authorized Person with the permission to enter into SWAP agreements to transfer the economic benefits of its ownership of shares in Saudi companies listed on the Saudi Stock Exchange to its non-resident foreign clients.

- Conducted transactions not less than SAR 40m, and not less than 10 transaction in each quarter during last 12 months.
- Have an average portfolio size of SAR 5m for the preceding 12 months
- Worked for at least 3 years in financial sectors.
- Hold General Securities Qualification Certificate which is recognized by the Authority.
- Holds professional certificate that is related to securities business and accredited by an internationally recognized entity



Monthly Report - Main Market Highlights



The total value of shares traded for the month ending 29 April 2021 amounted to SAR 188.56 billion, decreasing by 35.13% over the previous month; while total stock market capitalization reached SAR 9,655.61 billion at the end of this period, increasing by 0.26% over the previous month.

- The total value of shares purchased by "Saudi Investors" during this period amounted to SAR 172.14 billion representing 91.29 % of total buying activity, and sales of SAR 175.01 billion representing 92.81 % of total selling activity. Total ownership of "Saudi Investors" stood at 96.76 % of total market capitalization as of 29 April 2021, representing a decrease of 0.21 % from the previous month.
- The total value of shares purchased by "GCC Investors" during this period amounted to SAR 1.54 billion representing 0.82 % of total buying activity, and sales of SAR 2.35 billion representing 1.24% of total selling activity. Total ownership of "GCC Investors" stood at 0.53% of total market capitalization as of 29 April 2021, representing an increase of 0.01% from the previous month.
- The total value of shares purchased by "Foreign Investors" during this period amounted to SAR 14.88 billion representing 7.89% of total buying activity, and sales of SAR 11.21 billion representing 5.94% of total selling activity. Total ownership of "Foreign Investors" stood at 2.71% of total market capitalization as of 29 April 2021, representing an increase of 0.21% from the previous month.

Monthly Report - Nomu-Parallel Market Highlights



- ▼ The total value of shares traded for the month ending 29 April 2021 amounted to SAR 309.37 million, decreasing by 53.33% over the previous month; while total stock market capitalization reached SAR 12,505.37 million at the end of this period, increasing by 0.22% over the previous month.
- The total value of shares purchased by "Saudi Investors" during this period amounted to SAR 282.44 million representing 91.30% of total buying activity, and sales of SAR 288.76 million representing 93.34% of total selling activity. Total ownership of "Saudi Investors" stood at 98.91% of total market capitalization as of 29 April 2021, representing a decrease of 0.10% from the previous month
- The total value of shares purchased by "GCC Investors" during this period amounted to SAR 1.61 million representing 0.52% of total buying activity, and sales of SAR 17.32 million representing 5.60% of total selling activity. Total ownership of "GCC Investors" stood at 0.87% of total market capitalization as of 29 April 2021, representing a decrease of 0.05% from the previous month.
- The total value of shares purchased by "Foreign Investors" during this period amounted to SAR 25.31 million representing 8.18% of total buying activity, and sales of SAR 3.29 million representing 1.06% of total selling activity. Total ownership of "Foreign Investors" stood at 0.22% of total market capitalization as of 29 April 2021, representing an increase of 0.14% from the previous month.
