The fund will be passively managed by purchasing physical gold and storing it in Dubai Multi Commodities Centre (DMCC). The fund will purchase Shariah compliant spot gold contracts from DGEX to achieve performance of gold commodity on a daily basis, before the deduction of fees and expenses.

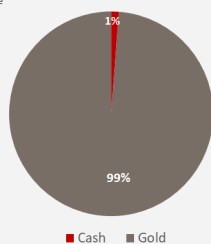

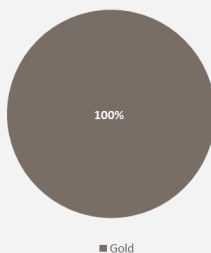
## A Graph Indicating the Fund's Asset Distribution

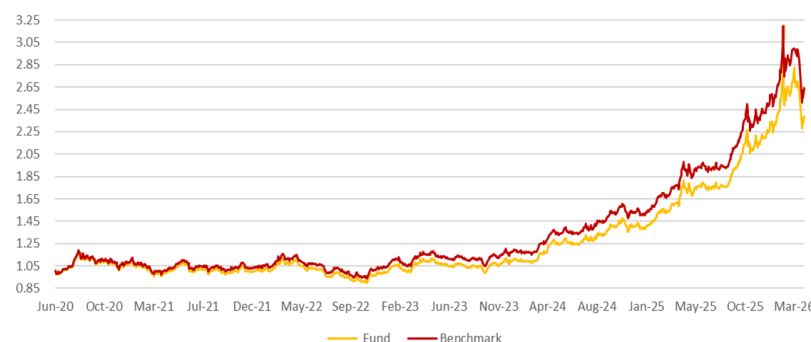
