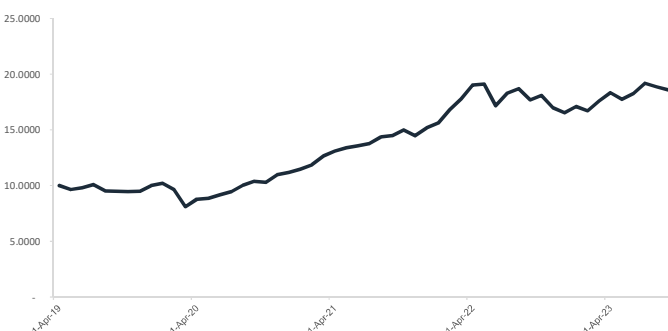

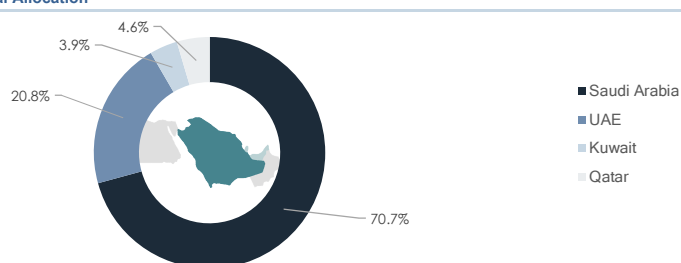

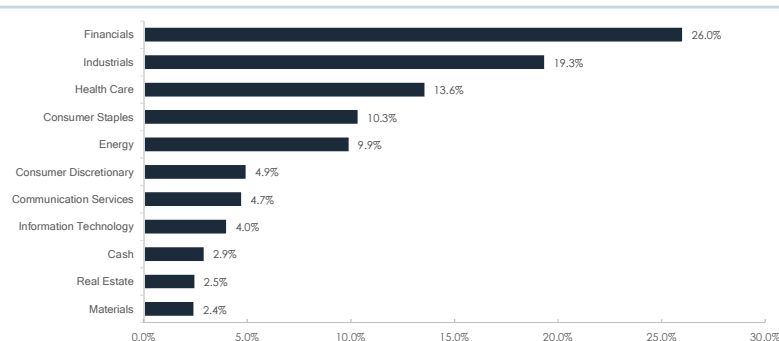

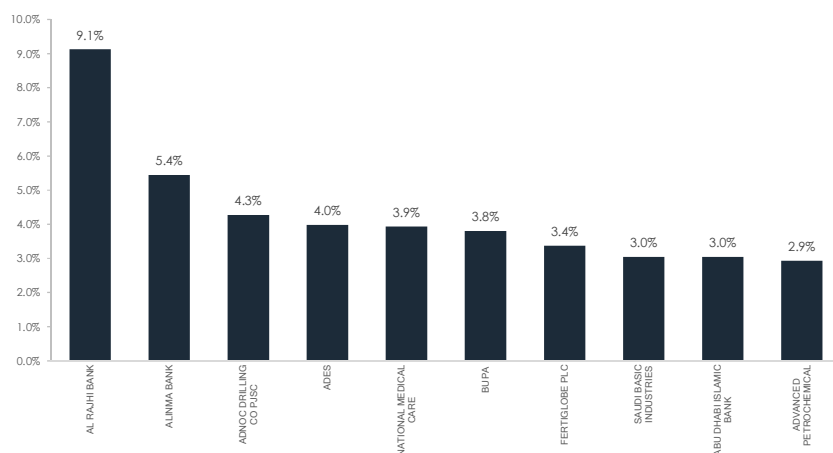
Geographical Allocation
