01	The Board of Directors Report for the fiscal year ended on 31 December 2025 was reviewed and discussed.
02	Approved the External Auditors' Report for the financial year ending on 31/12/2025 after discussing it.
03	The Company's Financial Statements for the fiscal year ended on 31 December 2025 was reviewed and discussed.
04	Approved the appointment of KPMG Professional Services as an independent auditor for the Company from among the candidates and based on the Audit Committee's recommendation, in order to examine, review, and audit the financial statements for the second, third quarters and the annual financial statements for the fiscal year 2026, as well as the first quarter for the fiscal year 2027, and the total fees of 885,000 SAR.
05	Approved the delegation of the authority of the Ordinary General Assembly to the Board of Directors with the authorization under Article 27(1) of the Companies Law, for a period of one year from the date of the General Assembly's approval or until the end of the delegated Board of Directors' term, whichever comes first, in accordance with the conditions stated in the Implementing Regulations of the Companies Law for Listed Joint Stock Companies.
06	Approved the delegation of the authority of the Ordinary General Assembly to the Board of Directors, with the authorization under Article 27(2) of the Companies Law, for a period of one year from the date of the General Assembly's approval, or until the end of the delegated Board of Directors' term, whichever comes first, for the activities of selling flour, bran, and feed.
07	Approved the disbursement of (1,400,000) SAR as remuneration to the Board members for the financial year ended on 31/12/2025.
08	Approved authorizing the Board of Directors to distribute interim dividends on a semi/quarterly basis for the financial year ended on 31/12/2025.
09	Approved the discharge of the members of the Board from any responsibility for the Company's management during the financial year 2025.
