THIRD QUARTER 2024 HIGHLIGHTS

SAUDI KAYAN EARNINGS RELEASE O3 2024









Revenue of SAR 2,398.63 million [\$ 639.63 million], a 13.9% increase quarter-over-quarter and a 12.2% increase year-over-year

EBITDA of SAR 488.3 million [\$ 130.2 million], a 5.6% decrease quarter-over-quarter and a 11.7% increase year-over-year.

Loss from operations of SAR 126.5 million [\$ 33.7 million] a 38.6% increased quarter-over-quarter and a 52% decrease compared to SAR 266 million [\$ 71 million] in the third quarter of 2023.





Free cash flow of SAR 65.05 million [\$ 17.3 million] was generated in the third quarter 2024 a decrease of 82.5% in prior quarter's free cash flow of SAR 371.89 million [\$ 99.17 million]

Net Loss of SAR 296.16 million [\$ 79 million], an increase by 18.4% versus net loss of SAR 250.09 [\$ 66.7 million] in prior quarter and an 34% decrease compared to the net loss of SAR 448.97 [\$ 119.7 million] in the third quarter of 2023.
