In compliance with Article (91) of the Corporate Governance Regulations issued by the Capital Market Authority, which states the following:

The Audit Committee held (4) meetings during the year 2020 AD, during those meetings, it carried out the following:

Evaluating the internal control system through what was stated in the internal audit report and auditing the results of its work to verify the integrity of the internal control system and to ensure that Company's management complies with implementing the procedures and recommendations contained in the internal audit report;

Auditing updates of some of the Company's financial policies and procedures to ensure the level of internal control procedures in those policies.

Auditing the annual financial statements and the interim briefed quarterly financial statements and discussing them with the external auditor.

Studying the accounting policies used in the Company and ensuring that they are updated in line with international standards adopted in the Kingdom.

Recommending the appointment of the Company's external auditor for the financial year ending on December 31, 2020, according to criteria that include technical and financial analysis, verifying his independence, and ensuring that there is no restrictions on the exercise of his duties;
