- 1. This form is to be filled out by the nominated/appointed member of the board of a listed joint stock company on the Saudi Stock Exchange ("the Company").
- 2. If the member is appointed by the board of directors of the company—based on paragraph (4) of Article 69 of the Companies Law—the member must send this form to the company immediately upon appointment.
- 3. The company shall attach this form, after completing the required data, in the electronic system specified by the Capital Market Authority at least three (3) working days before the General Assembly meeting.
