It describes how much excess return you receive for the volatility of holding a riskier asset.– <u>Tracking Error</u>: The divergence between the price behavior of a position or a portfolio and the price behavior of a benchmark.– <u>Beta</u>: A measure of the volatility or systematic risk of a security or portfolio compared to the market as a whole– <u>Alpha</u>: It is the excess return of an investment relative to the return of a benchmark index.– <u>Information index</u>: A measurement of portfolio returns beyond the returns of a benchmark, usually an index, compared to the volatility of those returns.






