It describes how much excess return you receive for the volatility of holding a riskier asset. <u>Tracking Error</u>: The divergence between the price behavior of a position or a portfolio and the price behavior of a benchmark. <u>Beta</u>: A measure of the volatility or systematic risk of a security or portfolio compared to the market as a whole. <u>Alpha</u>: It is a measure of the fund's value added relative to a benchmark. <u>Information index</u>: A measurement of portfolio returns beyond the returns of a benchmark, usually an index, compared to the volatility of those returns.

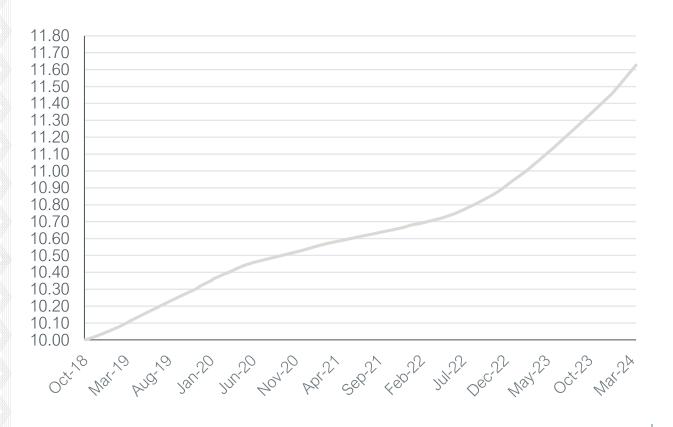
