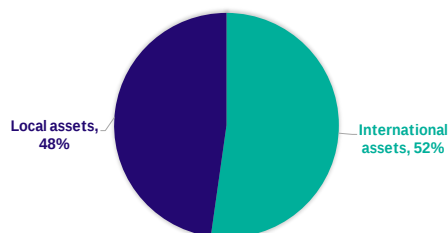


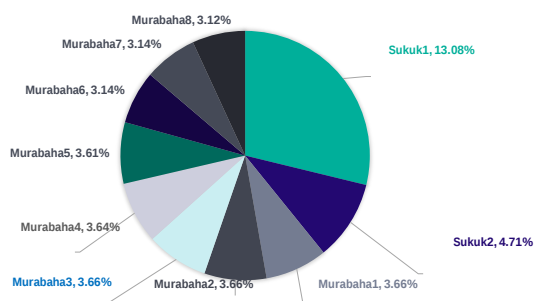

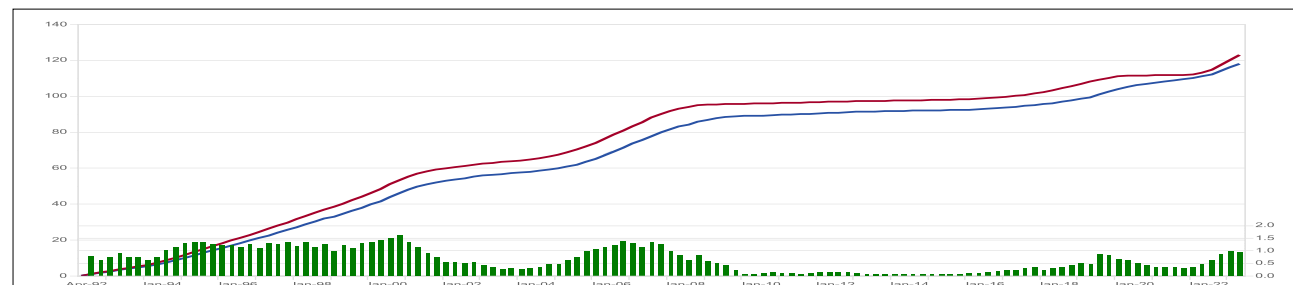
ASSET DISTRIBUTION BY GEOGRAPHICAL
