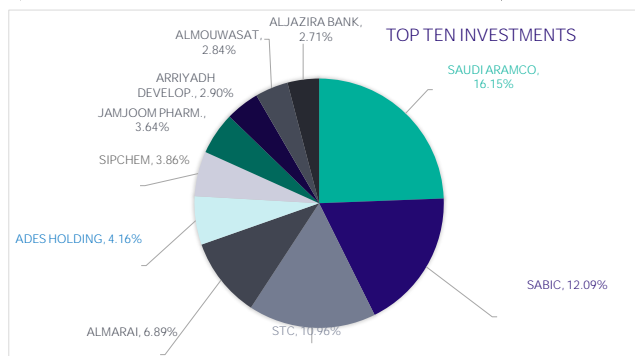
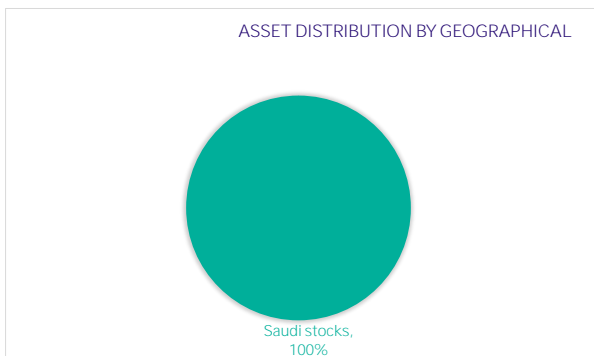
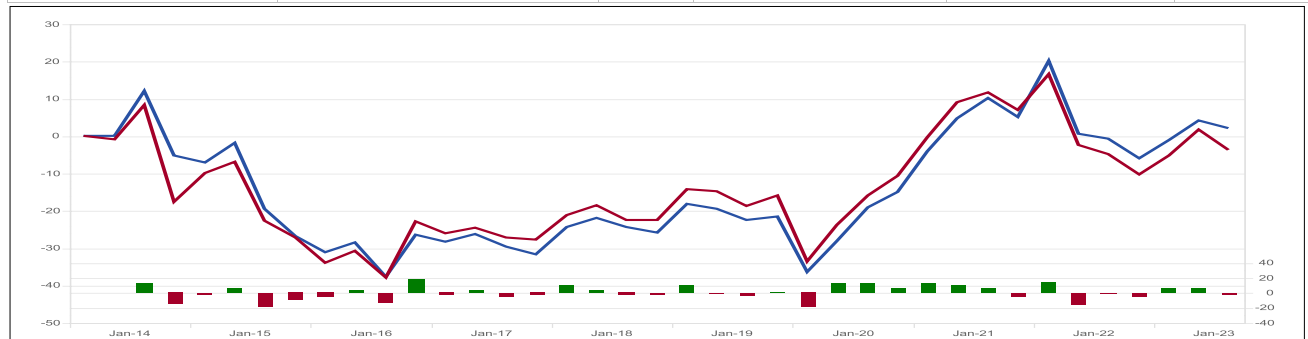


The objective of the fund	Date
