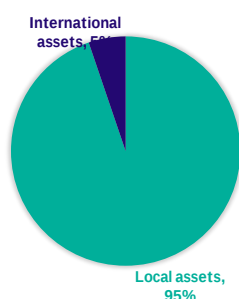
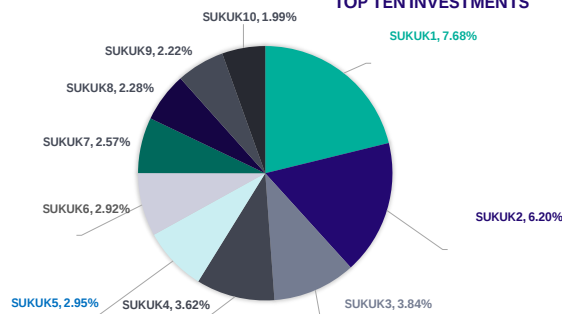

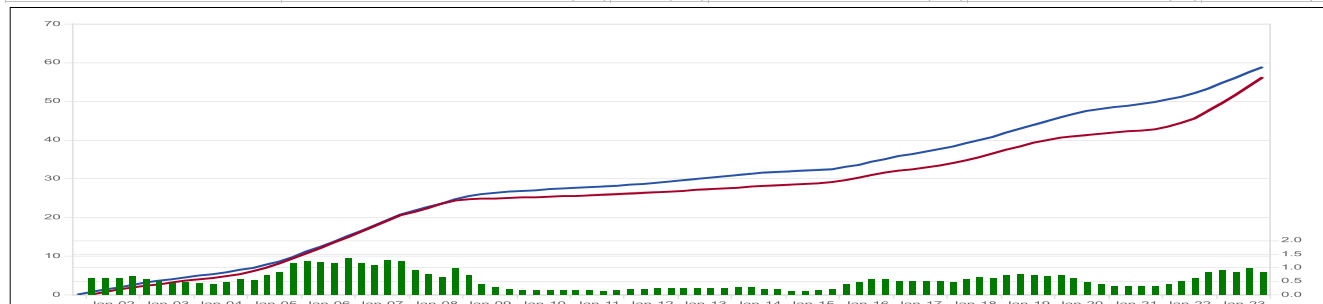
ASSET DISTRIBUTION BY GEOGRAPHICAL
