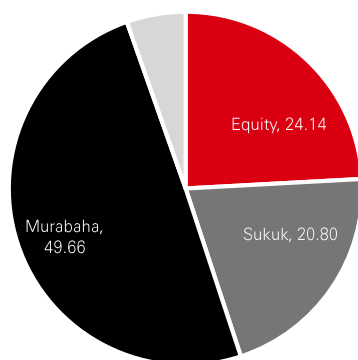

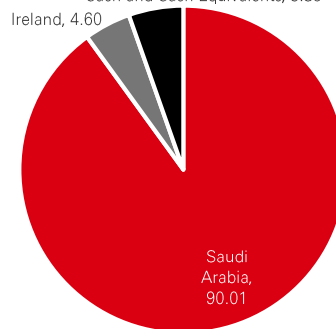
#### Asset Allocation (%)

Cash & Cash Equivalents, 5.39



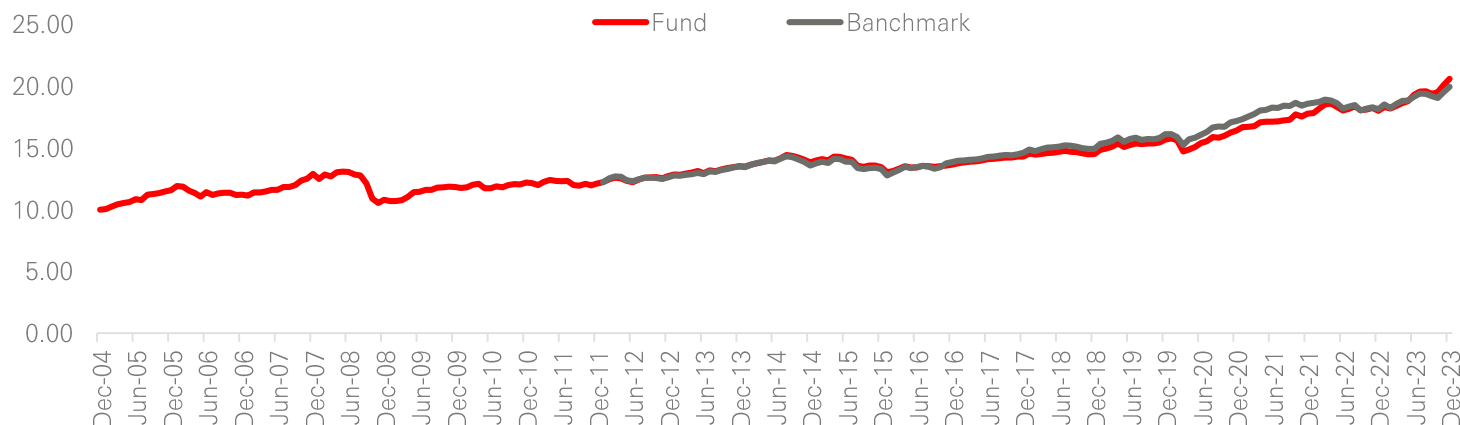
#### Geographical Allocation (%)
