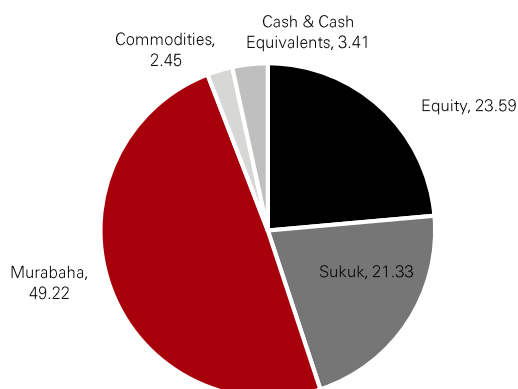

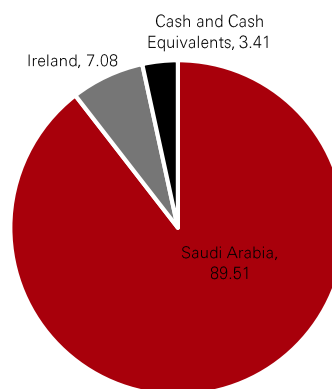

Asset Allocation (%) ⁽⁴⁾



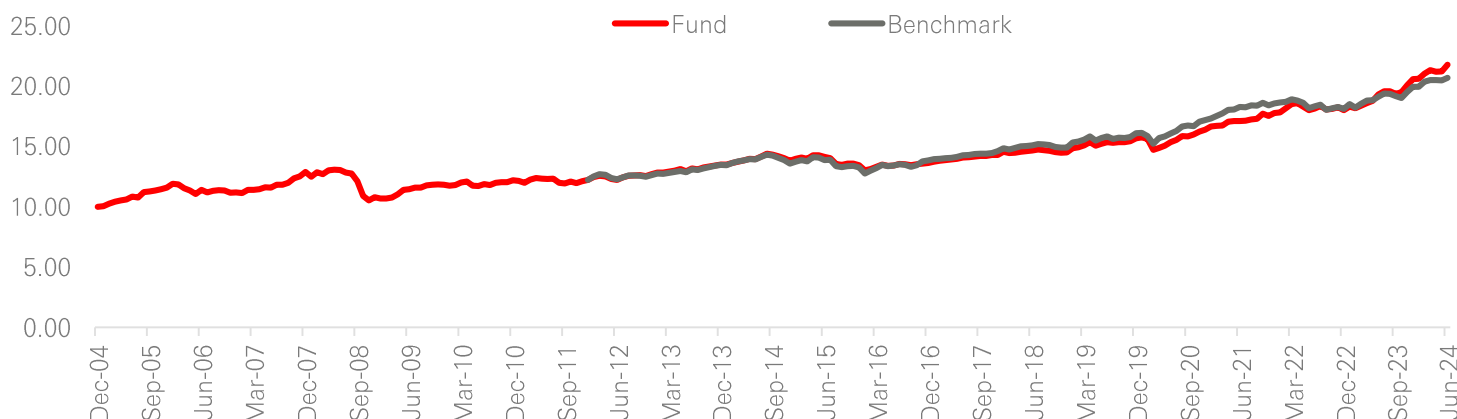
