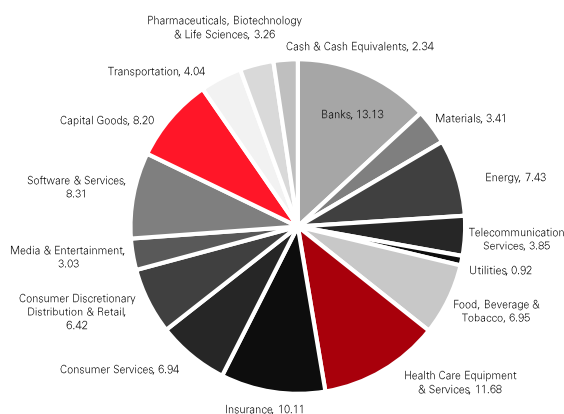

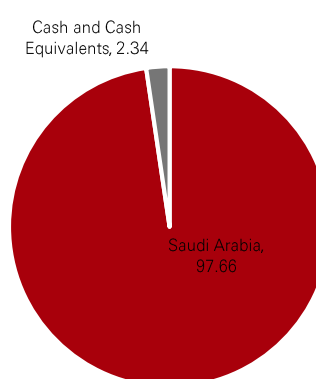

Sector Allocation (%) ⁽⁴⁾

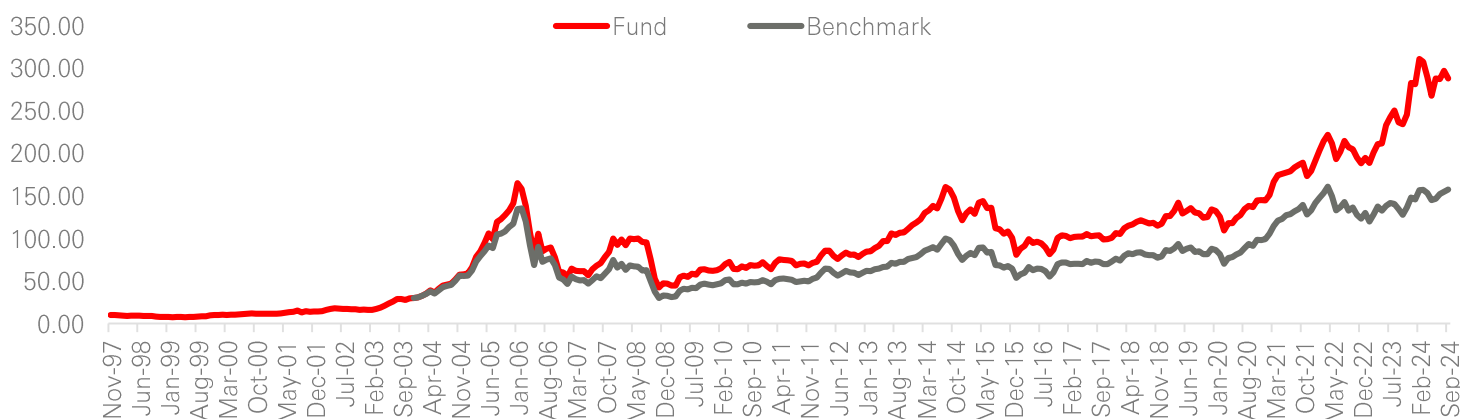


Geographical Allocation (%) ⁽⁴⁾
