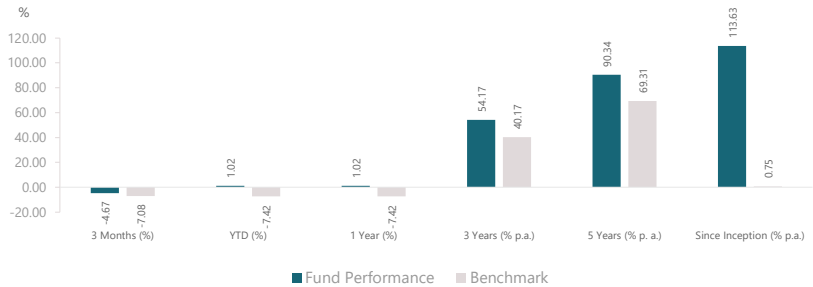

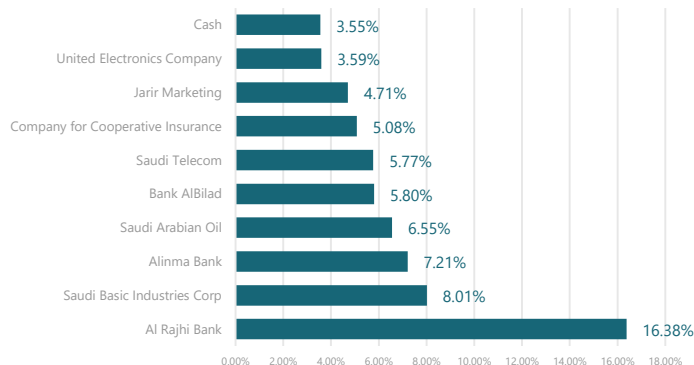

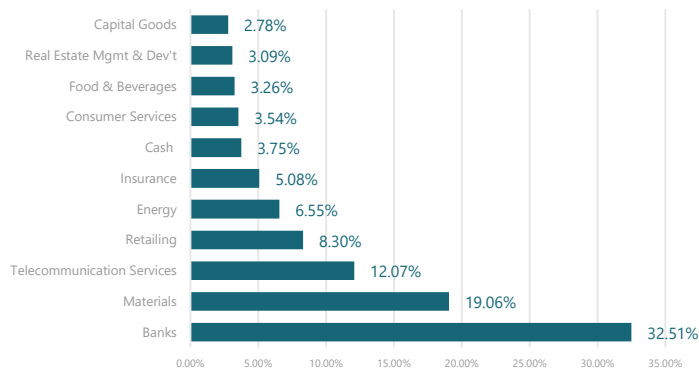

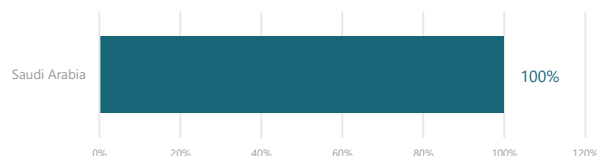
Top 10 Investments
