

Fund Objective

BSF Saudi Equity Income Fund is an open-end fund that seeks to outperform its benchmark in the medium to long term by investing in listed companies on the Saudi stock market that comply with the Sharia standards approved by the Sharia Committee

Its objective is to distribute cash dividends on a semi-annual basis which is the greater of the following:

- Either 2.5% of the Fund's net asset value per unit regardless of the Fund's performance during the period
- Or, if the unit price achieved its highest point since its inception, 50% of the difference between the unit price over its equivalent on the previous distribution day will be distributed.

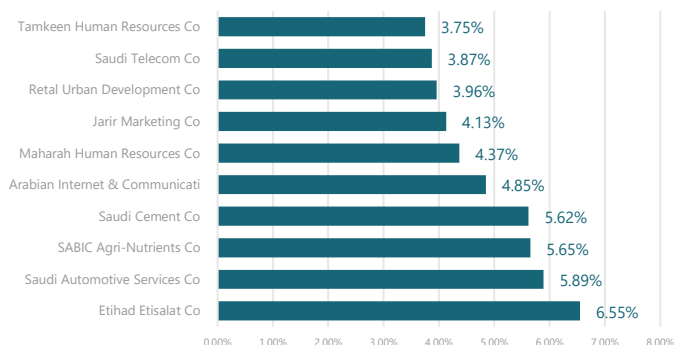

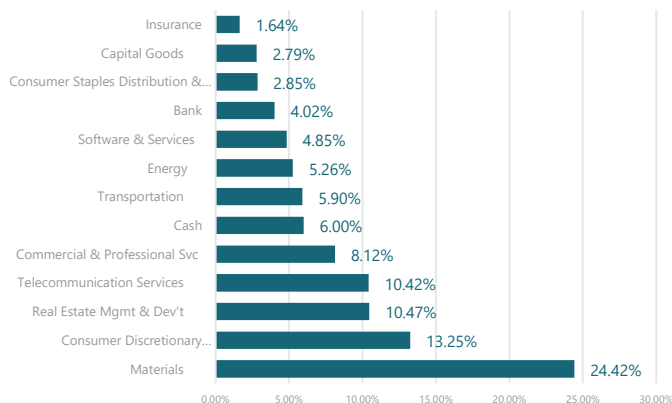

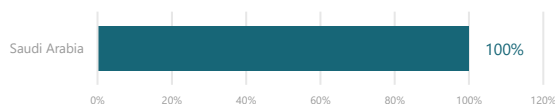
Sector Allocation
