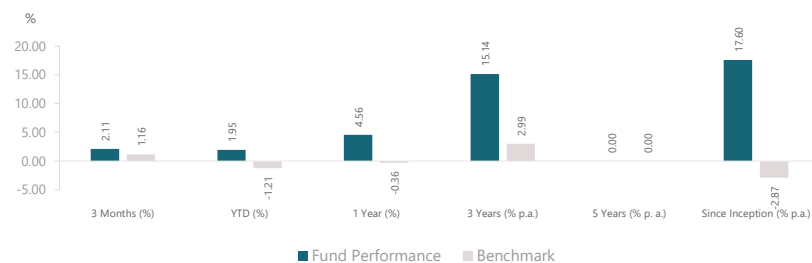

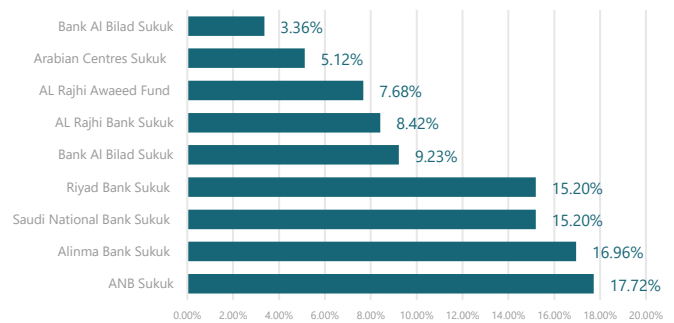

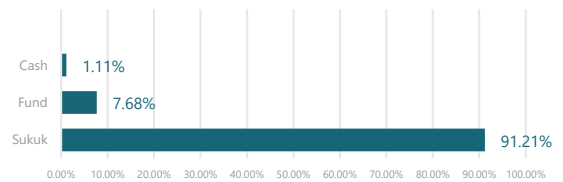


Asset Allocation

Asset Allocation

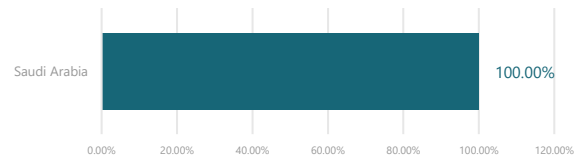


Geographical Allocation
