Asset Allocation Guidelines: The HSBC Multi-Assets Balanced Fund is a medium risk portfolio that limits equity exposure to 55%.

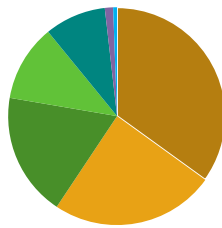

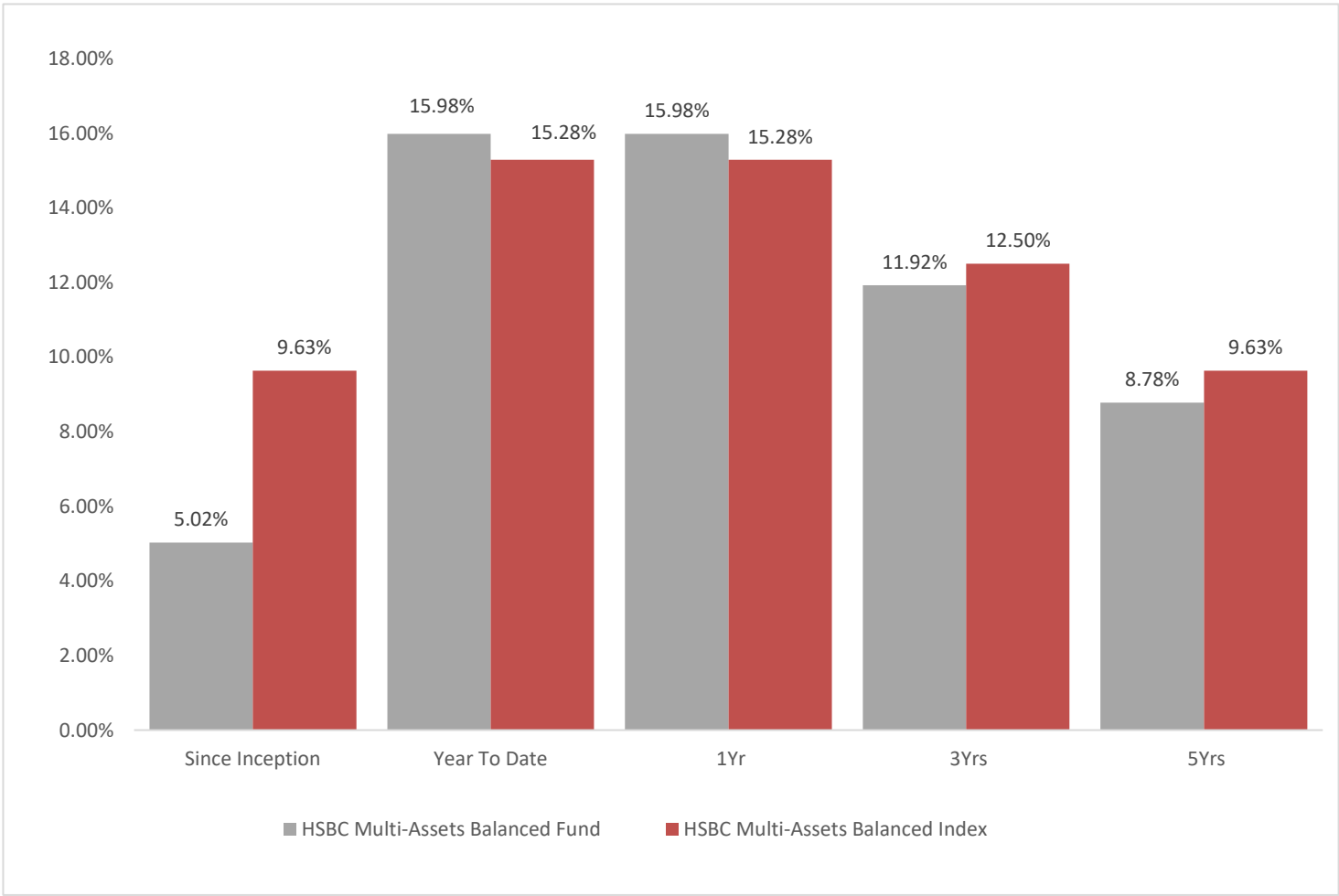
