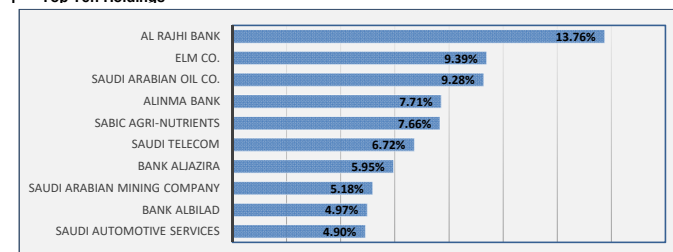

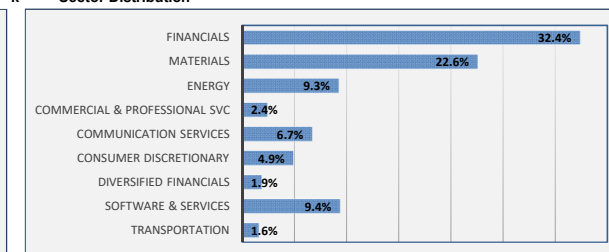

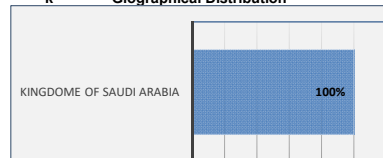
k Sector Distribution



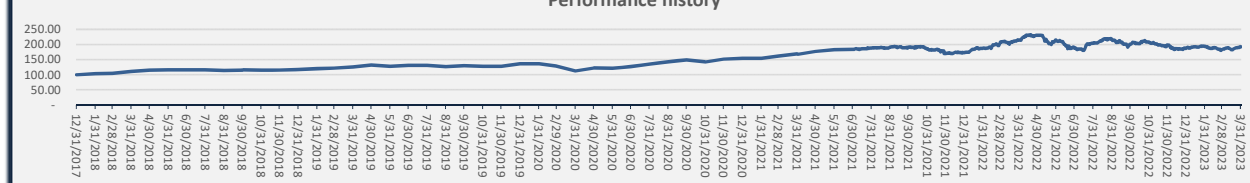
