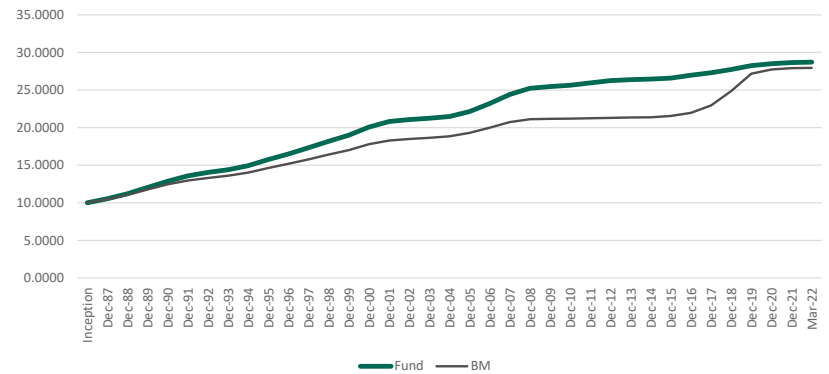

Manager Performance

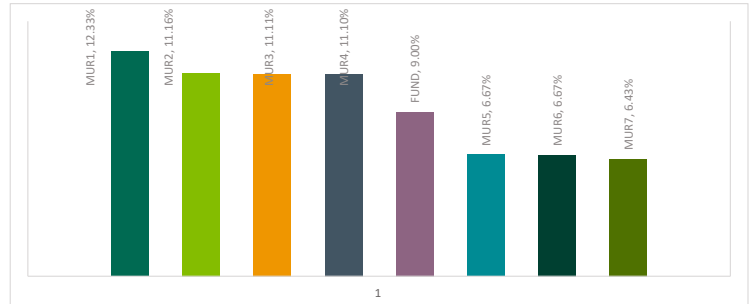
December 1986 - March 2022 (Single Computation)
