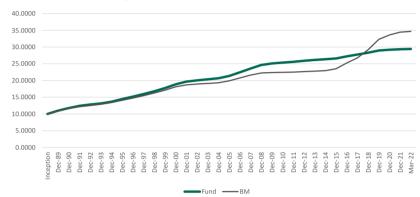

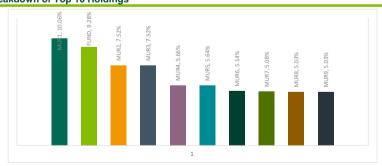
October 1988 - March 2022 (Single Computation)
