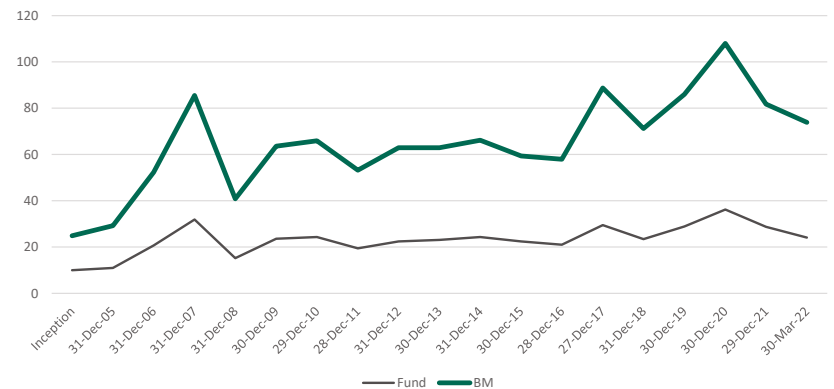

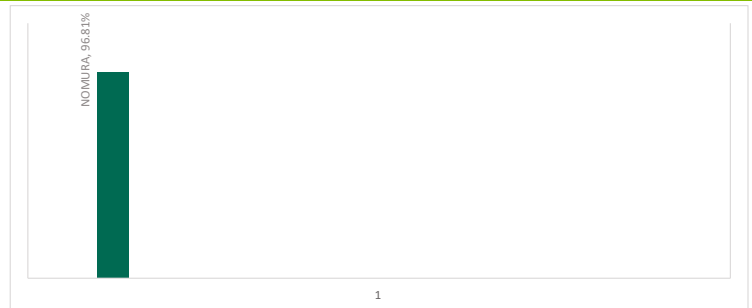
June 2005 - March 2022 (Single Computation)
