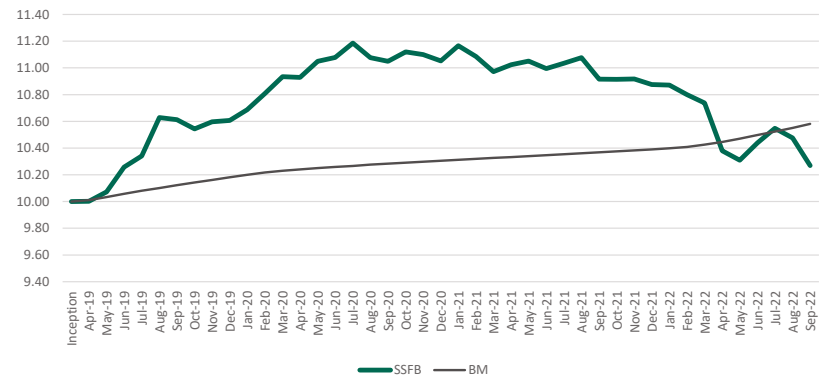

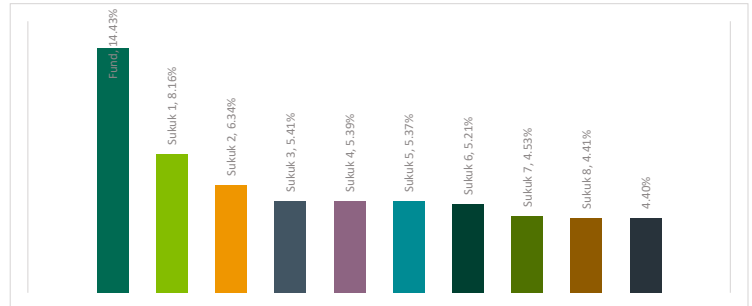
April 2019 - September 2022 (Single Computation)



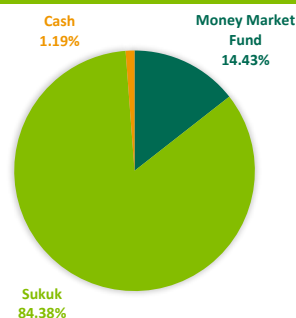
