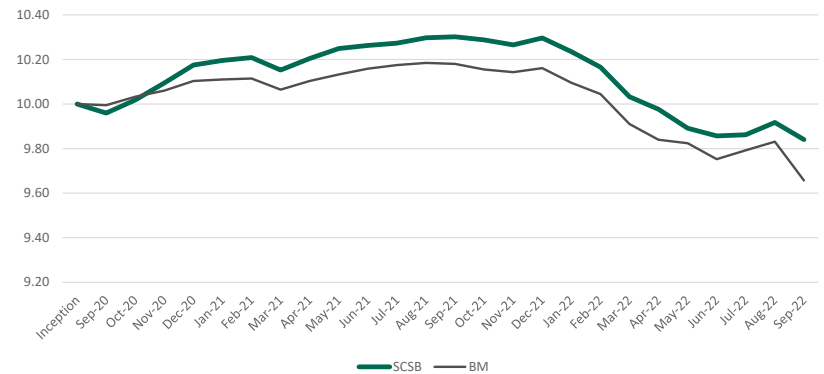

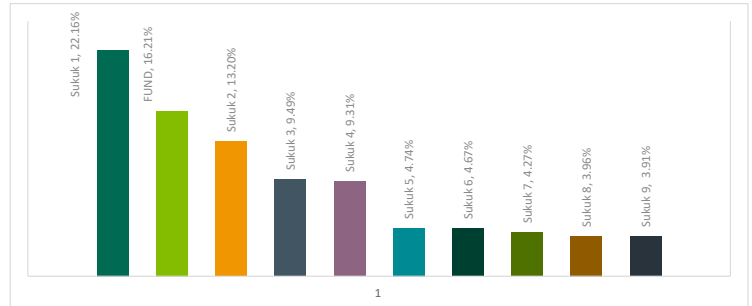
August 2020 - September 2022 (Single Computation)



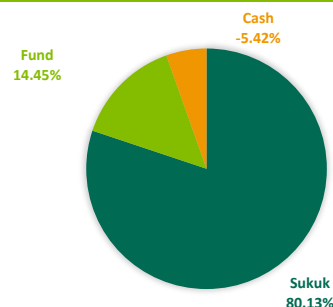
