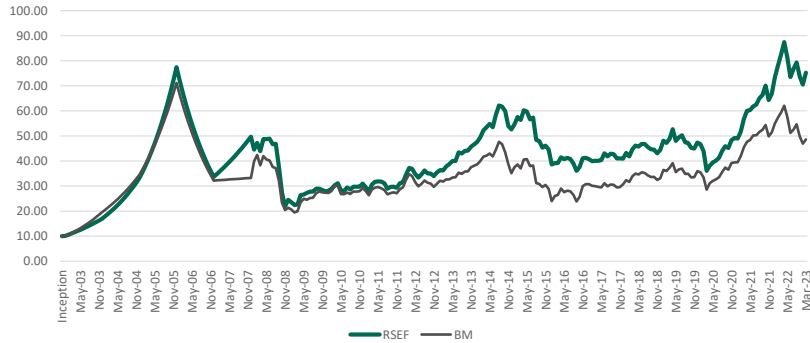

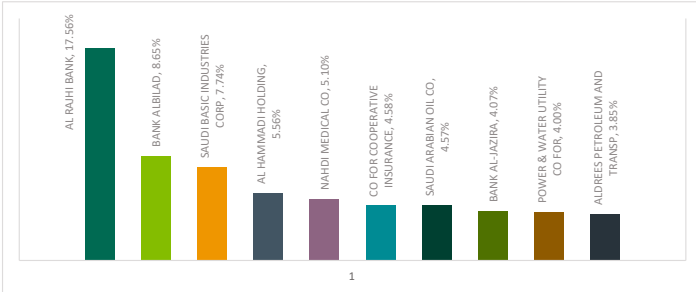
December 2002 - March 2023 (Single Computation)



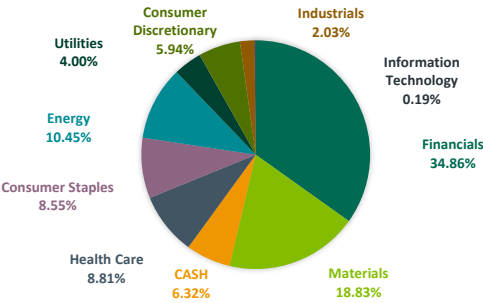
