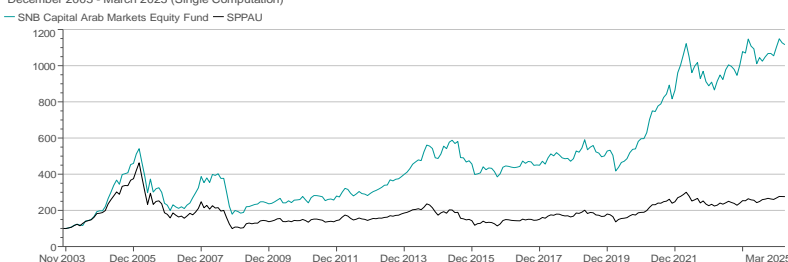

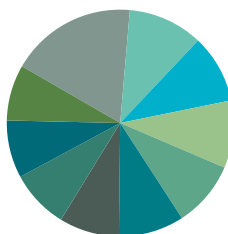
Manager Performance

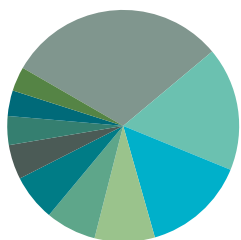
