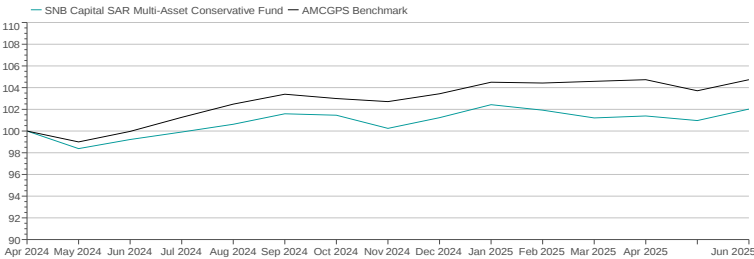

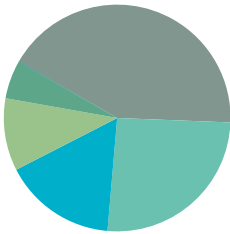
Manager Performance

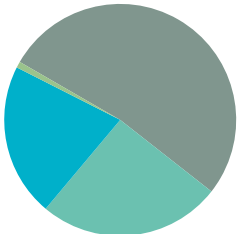
