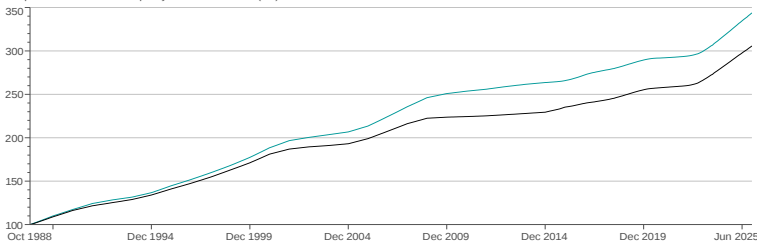

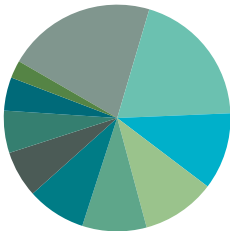
Manager Performance

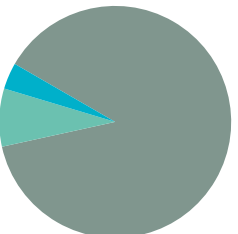
