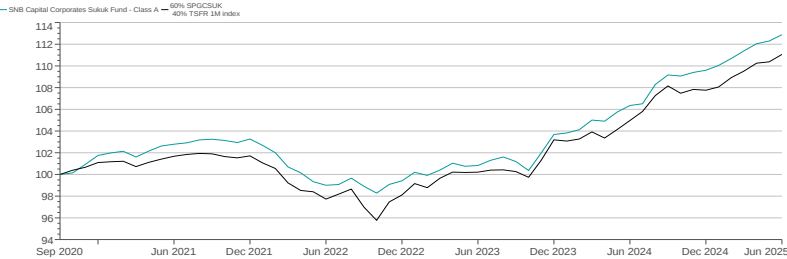

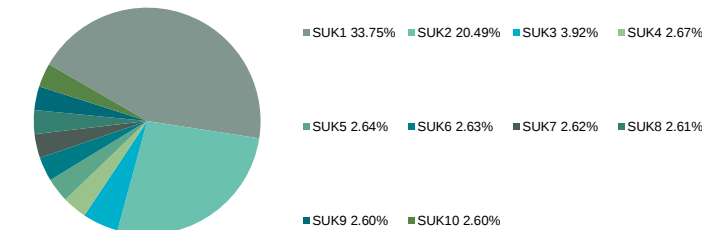
Manager Performance
October 2020 - June 2025 (Single Computation)



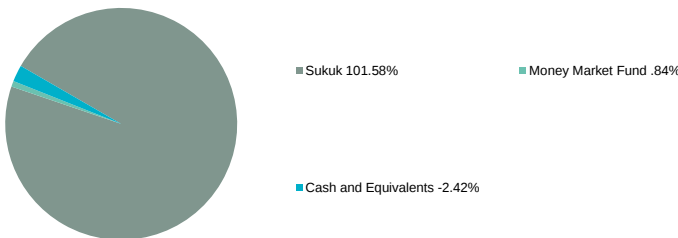
