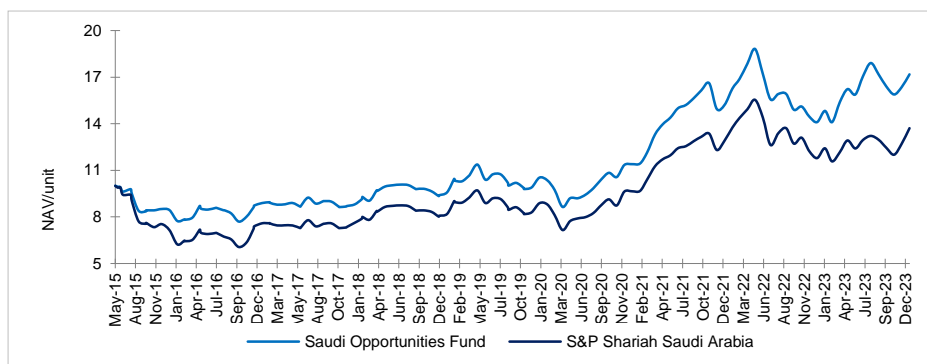

Cumulative Performance Since Launch



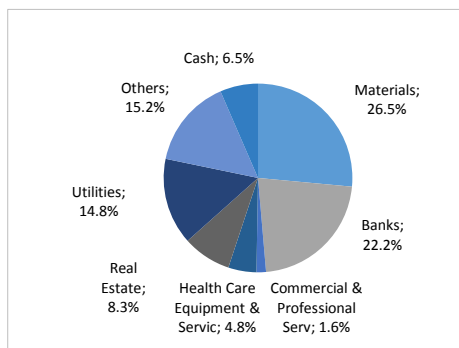

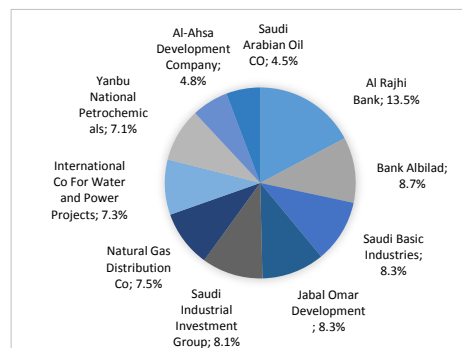
