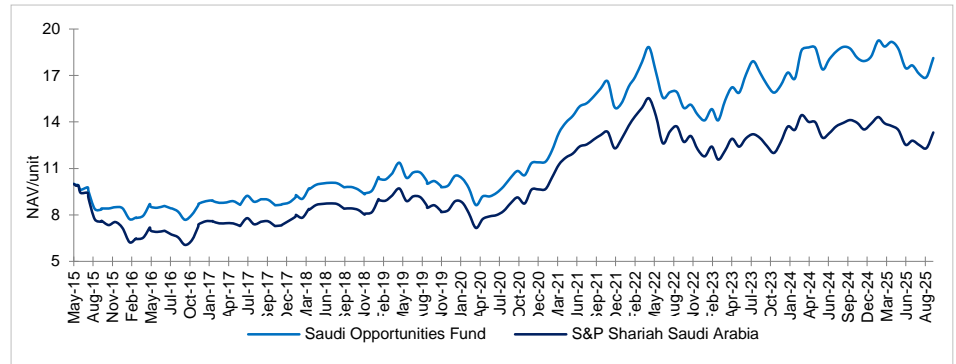

## Cumulative Performance Since Launch

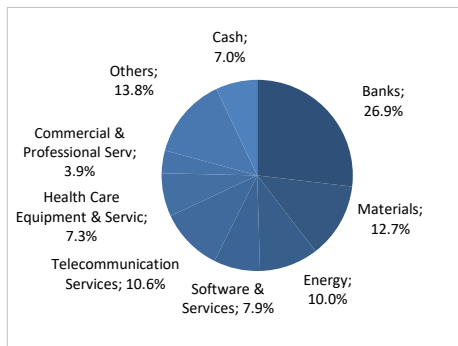

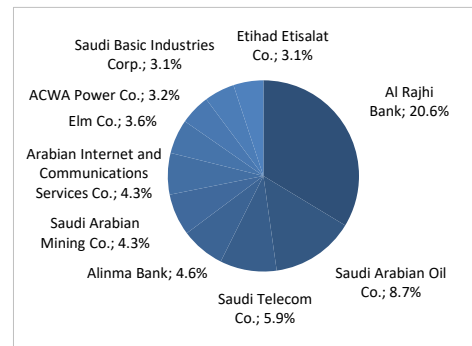
