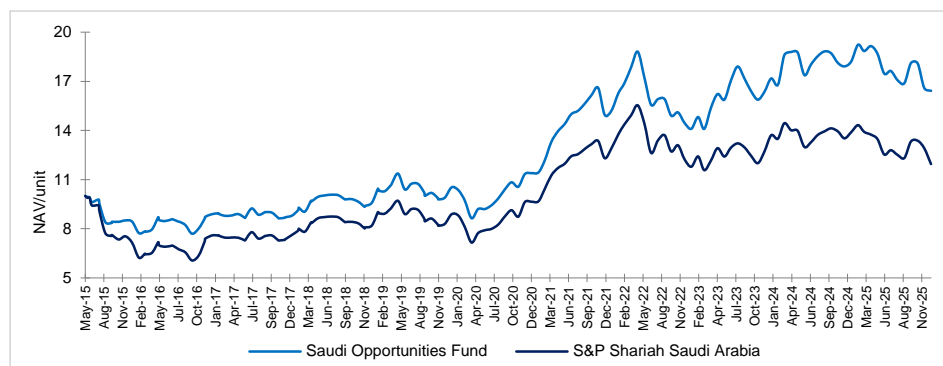

Cumulative Performance Since Launch

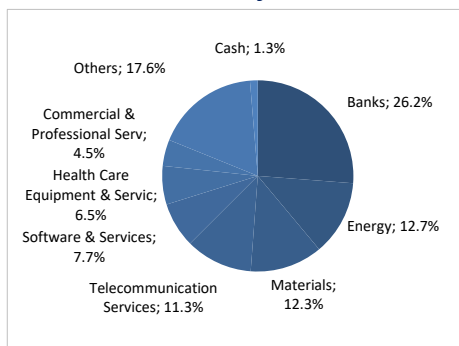

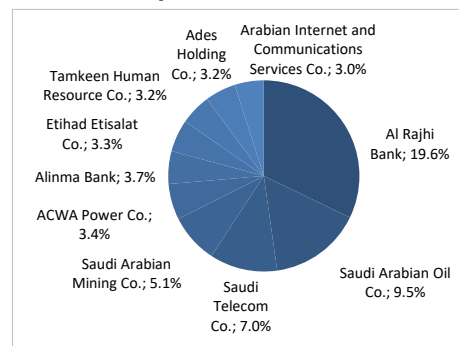
