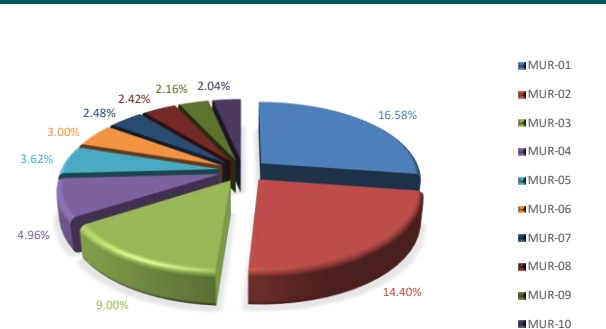

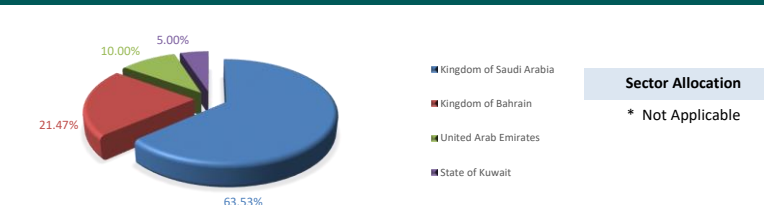

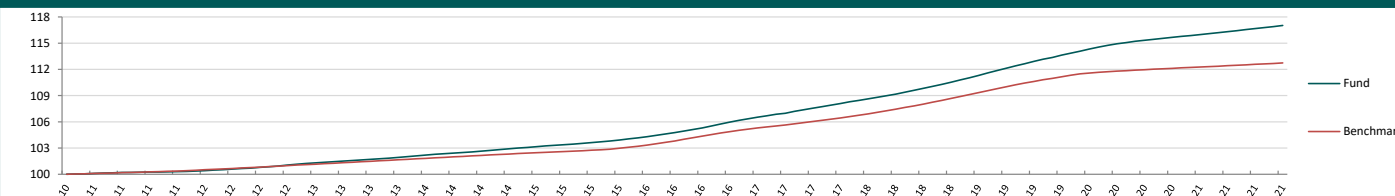
Fund's Asset Distribution (Sector/Geographic)
