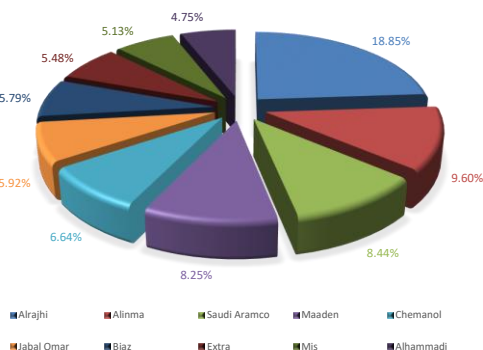
Objective of the Fund

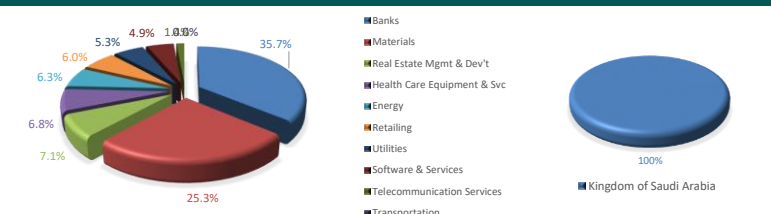

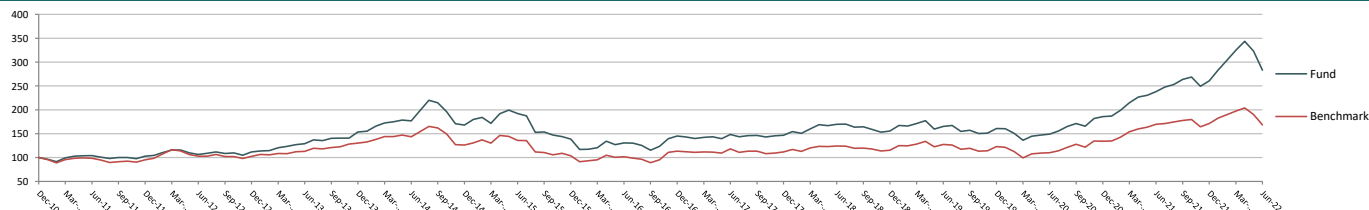
