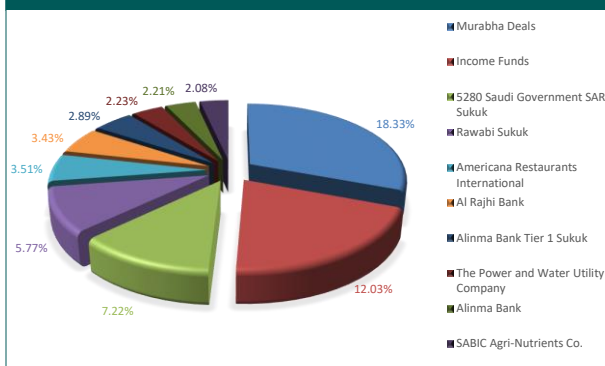
## Objective of the Fund

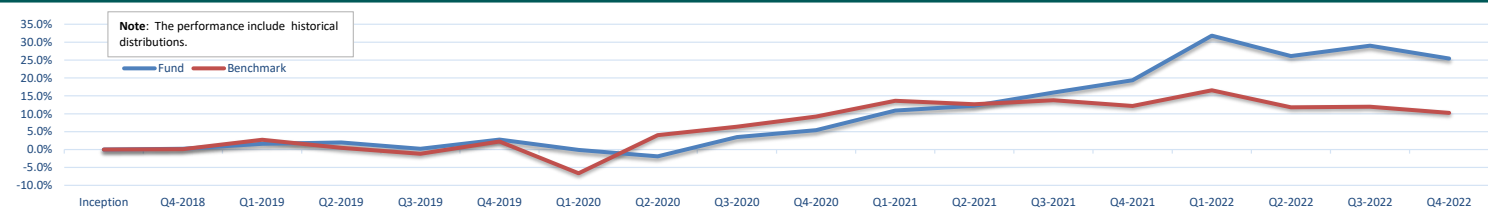

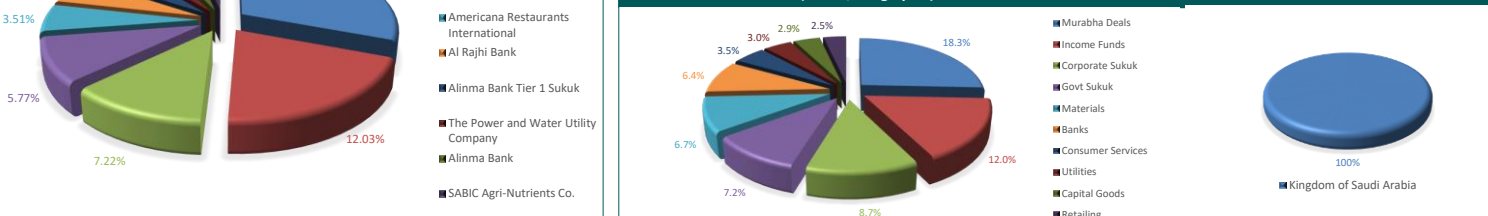
