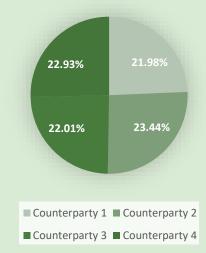

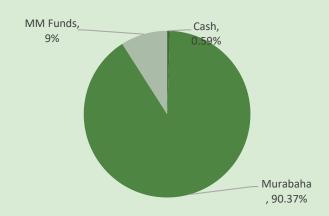
Baitk Liquidity Fund is an open-ended fund that invests in short to
