Articles of Association of Saudi Manpower Solutions Company, Listed Joint stock Company

(Listed Joint stock Company).

Chapter One: Company's Incorporation

Article One: Incorporation

In accordance with the provisions of the Companies Law issued by Royal Decree No. M/132 dated 1/12/1443H and its executive regulations, it is hereby established as a Saudi joint stock company based to the following:

Article Two: Company name

Saudi Manpower Solutions Company, Listed Joint stock Company (Joint stock Company).

Article Three: The company's head office

The company's head office is located in the city of Riyadh, and it may establish branches inside or outside the Kingdom by resolution from the Board of Directors.

Article Four: Company objectives

The company carries out and implements the following purposes:

The company carries out its purposes in accordance with applicable regulations and after obtaining the necessary licenses from the competent authorities, if any.

Article Five: Company's Term

The term of the Company is (99) years commencing from the date of its due registration in the commercial register. The term of the Company may always be extended by a resolution issued by the Extraordinary General Assembly at least one year prior to the expiration of its term.





Article Six: Participation and ownership in companies

The Company may solely establish companies, it may own shares in other existing companies or merge therewith. It also has the right to participate with others in the establishment of joint stock or limited liability companies after satisfying the requirements of regulations and instructions in this regard. The Company may also dispose of such interest or shares, provided that it does not include any brokerage.

Chapter Two: Capital and Shares

Article Seven: Capital

The Company's Share capital was set at four hundred million Saudi Arabian Riyals (SAR 400,000,000), divided into four hundred million (400,000,000) Shares, with an equal nominal value of one Saudi Arabian Riyals (SAR 1) each, all of which are ordinary Shares in exchange for cash shares, and the value paid from it in cash is four hundred million riyals (400,000,000) riyals. The cash amounts paid from the issued capital have been deposited in one of the licenced banks.

Article Eight: Subscription to Shares

Shareholders subscribed to the full issued capital shares amounting to 400,000,000 riyals fully paid.

Article Nine: Preferred shares

The Extraordinary General Assembly of the Company, in accordance with principles laid down by the competent authority, may issue preferred Shares and purchase the same, or convert regular Shares to preferred Shares, or convert preferred Shares to regular Shares. Such preferred Shares do not confer the right to vote in the General Assemblies of the Shareholders; but rather entitle their owners the right to obtain higher percentage of the net profits, after setting aside any reserves if available.

Article Ten: Sale of non-paid-up Shares

- The shareholder is obligated to pay the remaining value of the share on the designated dates. If he fails to pay on the designated date, the Board of Directors may, after informing him by registered letter or by any means of modern technology sell the stock at a public auction or in the capital market, as the case may be. Others Shareholders may have priority in purchasing the non-paying g shareholder's shares.
- 2. The Company shall collect the amounts due thereto from the sale proceeds and shall return any remaining amount to the Shareholder. If the sale proceeds are not sufficient to satisfy the due amounts, the Company may satisfy such amounts from the Shareholder's fund.





- 3. Rights associated with Shares of which the value is not paid by the due date shall be suspended until such Shares are sold or the due amount is paid in accordance with the provision of Paragraph (1) of this Article, it includes the right to receive a share of the net profits to be distributed and the right to attend shareholder assemblies and vote on their Resolutions. However, it is permissible the shareholder who defaults in payment until the day of sale may pay the value due from him in addition to the expenses spent by the company in this regard, and in this in this case, the shareholder has the right to request the profits that are decided to be distributed.
- 4. The Company shall cancel the certificate of the share sold in accordance with the provisions of this Article and shall provide the buyer with a new certificate bearing the serial number of the cancelled certificate. The sale shall be recorded in the Shareholders register along with the particulars of the new holder. The Shares shall be classified as nominal Shares and may not be issued at less than their nominal value. However, the Shares may be issued at a value higher than their nominal value, in which case the difference in value shall be added as a separate item in the Shareholders' equity and it may not be distributed as dividends to shareholders. A Share shall be indivisible vis à vis the Company. In the event that a Share is owned by several persons, they shall select one person from amongst themselves to exercise, on their behalf, the rights pertaining to such Share and they shall be jointly responsible for the obligations arising from the ownership of such Share.

Article Eleven: Trading of Shares

The Shares shall be classified as nominal Shares and may not be issued at less than their nominal value. However, the Shares may be issued at a value higher than their nominal value, in which case the difference in value shall be added as a separate item in the Shareholders' equity and it may not be distributed as dividends to shareholders. A Share shall be indivisible vis à vis the Company. In the event that a Share is owned by several persons, they shall select one person from amongst themselves to exercise, on their behalf, the rights pertaining to such Share and they shall be jointly responsible for the obligations arising from the ownership of such Share.

Article Twelve: Shareholders' Register

The company's shares are traded by registering in the shareholders' register prepared or contracted to be prepared by the company, which includes the names of the shareholders, their nationalities, and their locations. Their residence, professions, share numbers and the amount paid from them, and this entry on the share is indicated. The transfer of ownership of the nominal share shall not be considered vis-à-vis the company, or a third party, except from the date of registration in the aforementioned register. The company issues share certificates with serial numbers and signed by the Chairman of the company's management or whomever he delegates from the board members, and it is stamped with the company's seal and includes, in particular, the share, the number and date of the



ministerial Resolution issued for the license. The nominal value of the share, the amounts for establishing the company, the number and date of the ministerial Resolution announcing the establishment of a company, the value of the capital and the number of shares issued. The amount paid, the company's purpose in brief, its main position, and its duration. The shares must have coupons with serial numbers and include the share number attached to it.

Article Thirteen: The company buys, sells and mortgages its shares

The company may purchase its shares to be used as treasury shares pursuant to a Resolution issued by the extraordinary general assembly, setting a maximum limit of the shares subject to purchase and its purposes, in accordance with the controls set by the legislative authorities in this regard, and the shares purchased by the company shall not have votes in Shareholders' Assemblies. The company may sell treasury shares in one or several stages. The company may mortgage the shares, and the mortgage creditor will have a receivable Profits and the use of rights related to the share, unless otherwise agreed in the mortgage contract. The mortgage creditor may not attend Assembly meetings Shareholders do not vote therein. The company may purchase its shares and allocate them to the company's employees or its subsidiaries within the employee stock program in accordance with to the controls and conditions issued in this regard.

Article Fourteen: Capital Increase

The extraordinary general assembly may decide to increase the company's capital, provided that the capital has been paid in full. It is not required that the capital be paid in full if the unpaid portion of the capital is due to shares issued in exchange for converting debt instruments or financing instruments into shares and the period has not yet expired scheduled to be converted into shares. The extraordinary general assembly may, in all cases, allocate all or part of the shares issued upon increasing the capital to the employees in the company and its subsidiaries or some of them, or any of that. Shareholders may not exercise their pre-emptive rights when the company issues allocated shares for employees. 3. The shareholder who owns the share - at the time of issuing the extraordinary general assembly's Resolution approving an increase in the issued capital or the Board of Directors' Resolution. By approving its increase within the limits of the authorized capital - has pre-emptive right in subscribing to the new shares issued in exchange for cash shares, and he is informed of his priority - if found by registered letter to his address listed in the shareholder registry, or through modern technological means, with the capital increase resolution, the conditions and method of subscription and the dates on which said subscription begins and ends, subject to the type and class of Shares owned by him. The Extraordinary General Assembly may suspend the provided that what they get does not exceed what they requested from the new shares rights of the Shareholders to subscribe to Shares in a capital increase in



exchange for cash contribution or give priority to non-Shareholders when it deems that it is in the best interest of the Company.. The shareholder has the right to sell or waive the pre-emptive rights during the period from the time of issuance of the General Assembly's Resolution approving the capital increase until the last day to subscribe for new shares associated with these rights in accordance with the controls set by the competent authority. Taking into account what was stated in paragraph (4) above new shares are available to pre-emptive rights holders who requested subscription in proportion to the pre-emptive rights they own out of the total pre-emptive rights resulting from the capital increase, provided that what they get does not exceed what they requested from the new shares.

The remaining newly issued Shares shall be allotted to the pre-emptive right holders who have asked for more than their proportionate stake, in proportion to the pre-emptive rights they own out of the total pre-emptive rights resulting from the capital increase, provided that what they get does not exceed what they requested, any remaining newly issued Shares shall be offered to third parties, unless the extraordinary general assembly decides or the capital market.

Article Fifteen: Capital Decrease

The Extraordinary General Assembly may decide to decrease the Company's capital if it exceeds the need of the Company or if the Company suffered losses. And in the latter case only, the capital may be decreased to below the limit set in Article (Fifty-Nine) of the Companies Law. The resolution to decrease the capital shall not be issued until a statement prepared by the Board of Directors stating the grounds for such decrease, the Company's liabilities and the effect of the decrease on satisfying such liabilities is presented at the general assembly. Said statement shall include the report of the Company's auditor and may be presented to Shareholders in cases where the general assembly resolution is passed by circulation.

If the resolution to decrease the capital is because it exceeds the Company's needs, the creditors shall be invited to submit their objections to the decrease, if any, at least forty-five) days prior to the date set for the Extraordinary General Assembly meeting to decide on the decrease. The invitation shall include a statement indicating the amount of capital prior to and after the decrease, the date of the meeting and the date the decrease becomes effective. If a creditor objects to the decrease and submits supporting documents to the Company within the specified period, the Company shall pay the debt owed to him if it is due or provide him with a sufficient guarantee if it is not due. The creditor who notified the Company of his objection, may if the Company failed pay his due debt or failed to provide sufficient guarantee if it is not due, petition the competent





judicial authority prior to the date set for deciding on the decrease in the Extraordinary General Assembly meeting.

Chapter Three: Board of Directors

Article sixteen: Company management

(a) The company shall be managed by a Board of Directors consisting of (9) members, who must be natural persons elected by the Ordinary General Assembly of shareholders for a period not exceeding four years.

The founders appointed the first Board of Directors for a period of 4 years as follows:

(b) The method of work in the Board of Directors shall be determined as follows: The Board of Directors, in the cases it deems appropriate, shall have the right to discharge the company's debtors from their obligations in accordance with what it serves its interests, and the discharge is a right of the Board that may not be delegated.

The place for holding its meetings shall be determined by the Board of Directors. It is permissible to hold meetings, sign and record deliberations and Resolutions recording minutes using modern technology.

The correct quorum for the meeting shall be the presence of 50% of the members of the Board of Directors and the correct quorum for making Resolutions is the approval of 51% of the members, Board members may delegate others to attend meetings, the Board of Directors communication and invitation can be via regular mail or e-mail.

The rules for terminating membership are as follows: A Director's membership in the Board shall expire by the expiration of the Board's term or by expiration of the member's validity in accordance with any regulations or official instructions in force in the Kingdom, and the Board must call the Ordinary General Assembly to convene sufficiently before the end of the Board term; To elect a board of directors for a new term. If elections not possible, and current Board term has ended. the members continue to perform their duties until a board of directors is elected for a new term, provided that the



period does not exceed for ninety (90) days from the date of its end. However, the Ordinary General Assembly may at any time dismiss all members of the Board of Directors or some of them, without prejudice to the right of the dismissed member towards the company to claim compensation if the dismissal occurred for an illegal reason or in inappropriate time. A member of the Board of Directors may resign by submitting a written notification to the Chairman of the Board, provided that this is at an appropriate time, otherwise, responsible to the company for any damages resulting from retirement.

Article Seventeen: Expiry or termination of Board Membership

1. Board membership shall end at the end of its term or at the expiration of the member's authority in accordance with any regulations or instructions in force in the Kingdom. The General Assembly may (based on the recommendation of the Board of Directors) terminate the membership of any member who is absent from attending (three) consecutive meetings or (five) separate meetings during the term of his membership without a legitimate excuse accepted by the Board of Directors. membership shall end at the end of its term or at the expiration of the member's authority in accordance with any system or instructions in force in the Kingdom. The General Assembly may (based on the recommendation of the Board of Directors) the membership of any member who is absent from attending (three) consecutive meetings or (five) separate meetings during the term of the member's authority in accordance with any system or instructions in force in the Kingdom. The General Assembly may (based on the recommendation of the Board of Directors) the membership of any member who is absent from attending (three) consecutive meetings or (five) separate meetings during the term of his membership without a legitimate excuse accepted by the Board of Directors.

Article Eighteen: Authorities of the Board

Taking into account the powers assigned to the General Assembly, the Board of Directors shall have the broadest powers in managing the company in order to achieve its purposes

The Board of Directors is required to obtain the approval of the General Assembly when selling assets whose value exceeds (fifty percent) of the value of their total assets. whether the sale was made through one or several transactions, and in this case the transaction that results in an exceeding (fifty percent) of the asset value is considered the deal that requires the approval of the General Assembly, and this percentage is calculated from the date of the first deal that took place during the previous (twelve) months.

The Board of Directors may, within the limits of its jurisdiction, delegate one or more of its members or a third party to carry out certain task or to carry out acts.

Article Nineteen: Remuneration of the Board Members

- 1. The Board of Directors' remuneration consists of a percentage of net profits, inkind benefits, an attendance allowance for meetings, a specific amount, or what the Assembly determines.
- 2. The Board of Directors' report to the Ordinary General Assembly at its annual meeting must include a comprehensive statement of all the amounts received by Directors as remuneration, sitting allowance, expense allowance, and other benefits during the fiscal year. It should also include a statement of what Board members received in their capacity as officers or executives or what they received in exchange for technical, administrative or advisory services, and that also includes a statement of the number of Board meetings and the number of meetings attended by each member.





Article Twenty: Authorities of the Chairman, Vice Chaiman, Managing Director and the Board Secretary

The Board of Director shall appoint from among its members in its first meeting a Chairman and it may appoint from among of its members a Managing Director or a Deputy Chairman.

The Board of Directors appoints a Chief Executive Officer from among its members or others.

The Board of Directors appoints a secretary from among its members or from others. The Chairman of the Board of Directors may delegate (by written Resolution) some of his powers to other board members or others to carry out a specific task or carry out acts. The Deputy Chairman shall assume the Chairman's duties in his absence in case the Board of Directors does have a Deputy Chairman.





Article Twenty-One: Vacant Positions in the Board

If the position of a board member becomes vacant the board may appoint a qualified person with relevant expertise to provisionally fill the vacancy, the appointment shall be reported to the Commercial Register within fifteen working days from the date of such appointment and it shall be submitted to the Ordinary General Assembly in its first meeting. The appointed member shall complete the term of his predecessor. If the number of board members falls below the minimum number required for the validity of board meetings as stipulated in this Law or the Companies Law, the remaining members shall call for an Ordinary General Assembly meeting within sixty days to elect the required number of members.

Article Twenty-Two: Deliberations of the Board

The Resolutions of the Board of Directors are issued by a majority of the votes of the Board members present or represented at the meeting, and when the votes are equal, the opinion of the Board of Directors Chairman prevails or whoever heads the Board in his absence. The Board of Directors may issue Resolutions by circulation by presenting them to all members separately, unless one of the members requests in writing that meeting to be written for deliberation, and these Resolutions are presented to the Board of Directors at its first subsequent meeting. The Board deliberation and resolutions shall be in minutes, signed by the Chairman and the present members of the Board of Directors, and the Secretary. The minutes shall be recorded in a special register signed by the Chairman of the Board and Board Secretary.

Article Twenty-Three: Formation of the Audit Committee

An Audit Committee shall be formed by a resolution of the Company's Board and the members of the audit committee shall be from the Shareholders or others, provided that no Executive Director is among its members. The number of the members of the Audit Committee shall not be less than three or more than five, provided that one of its members is specialized in finance and accounting. The chairman of the Audit Committee shall be an Independent Director. Any person who works or has worked in the Company's finance Department, the Executive Management or for the Company's external Auditor during the preceding two years may not be a member of the Audit Committees of more than five listed joint stock companies at the same time.

Article Twenty-Four: Quorum for the Audit Committee meeting

Audit Committee meetings are valid if attended by a majority of its members. Resolutions of the Audit Committee shall be issued by a majority of the votes present and, in case of a tie, the chairman of the Audit Committee shall have the casting vote.





Article Twenty-Five: Jurisdictions, powers, and responsibilities of the Audit Committee:

The Audit Committee is responsible for monitoring the company's business and verifying the soundness and integrity of its reports, financial statements and internal control systems. Its tasks include: The committee, in particular, includes the following: Financial reports: studying the company's initial and annual financial statements before presenting them to the Board of Directors and expressing its opinion and recommendation. In this regard; To ensure its integrity, fairness and transparency. Expressing a technical opinion upon the request of the Board of Directors regarding whether the Board of Directors' report and financial statements. The company is fair, balanced and understandable and includes information that allows shareholders and investors to evaluate the company's financial position, performance and business model and its strategy. Study any important or unusual issues included in the financial reports. Carefully research any issues raised by the company's financial director or whoever is in charge of the duties or duties are the company's compliance officer or auditor. Verifying accounting estimates on material issues contained in financial reports. Study. The accounting policies followed in the company and expressing an opinion and recommendation to the Board of Directors regarding them. Internal audit: study and review of internal control systems and risk management in the company. Study internal audit reports and follow up on the implementation of corrective measures for the observations contained therein. Oversight and supervision. On the performance and activities of the internal auditor and internal audit department in the company; To verify the availability of the necessary resources and their effectiveness in performing the assigned work and tasks with it. Auditor: Recommending to the Board of Directors to nominate the auditor, dismiss them, determine their fees, and evaluate their performance, after verifying their independence.

Review the scope of their work and the terms of their contract. Verifying the auditor's independence, objectivity, and fairness, and the effectiveness of the audit work, along with taking into account relevant rules and standards. Review the company's auditor's plan and audit work, and verify that he does not submit technical or technical work about the scope of the audit work, and expressing its views thereon. Answering the company auditor's inquiries. Study report, administrative or advisory, etc. The auditor and his comments on the financial statements and follow-up on what was taken regarding them. Ensuring compliance: reviewing and verifying the results of regulatory authorities' reports and the company takes the necessary measures regarding it. Verifying the company's compliance with relevant laws, regulations, policies and instructions. Review contracts transactions proposed to be carried out by the company with related parties, and presenting its views regarding that to the Board of Directors. The Board of Directors must take action regarding it, and make its recommendations regarding the actions that must be taken. If there is a conflict between the recommendations of the audit committee and the Resolutions of the Board of Directors, or if the Board refuses to take into account the committee's recommendation regarding the appointment of the company's auditor, his dismissal, determining his fees, and evaluating his performance, or appointing the





internal auditor. The Board of Directors' Resolution must include the committee's recommendation, its justifications, and the reasons for not taking it into consideration.

Chapter Four: Shareholders' Assemblies

Article Twenty-Six: Inviting Assemblies

- 1. General and private assemblies are held at the invitation of the Board of Directors, and the Board of Directors must invite the Ordinary General Assembly to convene within (thirty) days from the date of the request of the auditor or one or more shareholders representing (ten percent) of the company's shares that have at least voting rights. It is permissible to the auditor may convene the ordinary general assembly if the Board does not extend the invitation within (thirty) days from the date of the auditor's request referred to in Paragraph (1) of this Article must state the issues on which shareholders are required to vote.
- 2. The request referred to in Paragraph (1) of this Article must state the issues on which shareholders are required to vote.
- 3. The invitation to convene the assembly must be sent at least (twenty-one) days before the date specified for it in accordance with the provisions of the system, taking into account the following:

A - Informing shareholders through registered letters to their addresses listed in the shareholders' register, or announcing the invitation through modern technological means.

B - Sending a copy of the invitation and agenda to the Commercial Registry, as well as a copy to the Capital Market Authority if the company is listed in The financial market on the date of announcing the invitation.

4. The invitation to the Assembly's meeting must include at least the following:

A - A statement of the right holder to attend the assembly meeting and his right to delegate whomever he chooses from other than members of the Board of Directors, and a statement of the shareholder's right to discuss the matter.

Topics on the Assembly's agenda, asking questions, and how to exercise the right to vote.

B - The place, date and time of the meeting.

C - The type of Assembly, whether it is a public or private Assembly

D - The meeting agenda, including the items on which shareholders are required to vote.

Article Twenty-Seven: Voting in assemblies

Article Twenty-Eight: Preparing the assemblies minutes of meetings

1. At the assembly meeting, minutes shall be drawn up that include the number of shareholders present, personally or on behalf, and the number of shares in their possession, personally or on behalf, The number of votes assigned to it, the Resolutions taken, the number of votes that approved or opposed it, and a comprehensive summary of the discussions that took place in the meeting. Minutes are recorded on a regular basis after each meeting in a special register signed by the Assembly's president, secretary, and vote collectors.

Article Twenty-Nine: Attendance of assemblies

Every subscriber, regardless of the number of shares he holds, has the right to attend the constituent assembly, and every shareholder has the right to attend the general assemblies of shareholders, and in doing so he has the right to He appoints another person, other than members of the Board of Directors or employees of the company, to attend the General Assembly on his behalf.

Article Thirty: Powers of the Ordinary General Assembly

Except for matters within the jurisdiction of the Extraordinary General Assembly, the Ordinary General Assembly is concerned with all matters related to the company, and it meets once in a while at least per year during the six months following the end of the company's fiscal year. Other ordinary general assemblies may be called whenever the need arises.

Article Thirty-One: Powers of the Extraordinary General Assembly

Powers of the Extraordinary General Assembly: - Amending the company's bylaws, with the exception of matters prohibited from being amended by law. It may issue Resolutions of matters that are originally within the jurisdiction of the Ordinary General Assembly, subject to the same terms and conditions established for the Ordinary General Assembly. - Continuation report of company or Dissolution - Approval of the company's purchase of its shares.

Article Thirty-Two: Record of assemblies attendance

Shareholders who wish to attend the General Assembly register their names at the company's main office or register their names and declare their desire to attend by sending an email to the company center before the time specified for the assembly. Shareholders





have the right to participate by attending the General Assembly. Its deliberations are carried out by means of modern technology in accordance with the controls set by the competent authorities.

Article Thirty-Three: Quorum for the ordinary general assembly meeting

4) The ordinary general assembly meeting will not be valid unless it is attended by shareholders representing a quarter (1/4)

At least from Company shares that have voting rights on, and if the quorum necessary to hold this meeting is not available, the second meeting shall be held one hour after the end of the period , provided that the invitation to hold the first meeting includes an announcement of the possibility of holding this meeting. If the first invitation does not include anything indicating the possibility of a contract

The second meeting: An hour after the end of the period specified for the first meeting, an invitation was sent for a second meeting to be held within the following thirty (30) days.

For the previous meeting, this invitation shall be published in the manner stipulated in the Invitation to Assemblies Article of these regulations, and in all cases the meeting shall be held the second is valid regardless of the number of shares represented in it.

Article Thirty-Four: Quorum for the extraordinary general assembly meeting

2) The extraordinary general assembly meeting is not valid unless it is attended by shareholders representing half (1/2) Company shares that have voting rights on

If this quorum is not present in the first meeting, the second meeting shall be held one hour after the end of the period specified for the first meeting, provided that

The invitation to hold the first meeting includes an announcement of the possibility of holding this meeting. In all cases, the second meeting is valid if attended a number of shareholders representing one quarter (1/4) Company shares that have at least voting rights. If the necessary quorum is not met at the second meeting, shall be directed.

An invitation to a third meeting to be held in the same conditions stipulated in the Invitation to Assemblies Article of this law, and the third meeting shall be valid regardless of the number of shares represented in it

Article Thirty-Five: Resolutions of the Assemblies

The Resolutions of the Ordinary General Assembly are issued by a majority of the voting rights represented at the meeting, and the Resolutions of the Extraordinary General Assembly are issued by the approval of two-thirds voting rights represented at the meeting, unless it is a Resolution related to increasing or reducing capital, extending the term of the company, or dissolving it before the expiry of the term specified in these regulations or by its merger with another company, it will not be valid unless it is issued by a majority of three-quarters of the voting rights represented at the meeting.





Article Thirty-Six: Discussion in the assemblies

Every shareholder has the right to discuss the topics included in the Assembly's agenda and direct questions regarding them to the members of the Board of Directors and the auditor.

The Board of Directors or the auditor answers shareholders' questions to the extent that does not expose the company's interest to harm. If the shareholder believes that the response to the question was not sufficient. He appealed to the Assembly, and its Resolution in this regard was effective.

Article Thirty-Seven: Presidency of assemblies

The meetings of the general assemblies of shareholders shall be chaired by the Chairman of the Board of Directors, or his deputy in his absence, or whomever the Board of Directors delegates from among its members for that purpose.

In the absence of the Chairman of the Board of Directors and his deputy. At the assembly meeting, minutes shall be drawn up that include the number of shareholders present or represented and the number of shares held possession in person or by proxy, the number of votes assigned to them, the Resolutions taken, the number of votes that approved or disagreed with them, and a comprehensive summary. For the discussions that took place at the meeting, the minutes are recorded on a regular basis after each meeting in a special register signed by the Assembly's president and secretary.

Chapter Five: Auditor

Article Thirty-Eight: Appointment of auditor

The company must have an auditor (or more) from among the auditors licensed to work in the Kingdom, appointed by the General Assembly, and his fees shall be determined. The term of his work, and he may reappoint him, provided that this period does not exceed the maximum stipulated in the executive regulations of the companies' law. It is permissible the Assembly also has the right to isolate itself at any time, without prejudice to its right to compensation if the change occurs at an inappropriate time or for an illegal reason.

Article Thirty-Nine: Powers of the Auditor

The auditor has the right at any time to review the company's books, records and other documents, and he also has the right to request the data and clarifications he deems appropriate. It is necessary to obtain it, in order to verify the company's assets, liabilities, and other matters that fall within the scope of his work. The Chairman of the Board of





Directors must enable him of performing his duty, and if the auditor encounters difficulty in this regard, he shall prove that in a report submitted to the Board of Directors. The auditor must ask the Board of Directors to invite the Ordinary General Assembly to consider the matter.

Chapter Six: Company's Finance's and Distribution of Dividends

Article Forty:

- 1. The company's fiscal year shall be twelve Gregorian months, beginning on the 1st of January and ending at the end of the 31st of December.
- 2. A budget is prepared independently of the transitional period resulting from the amendment of the fiscal year.

Article Forty-One: Financial Documents

At the end of each fiscal year of the company, the Board of Directors must prepare the company's financial statements and a report on its activity and financial position for the fiscal year over the past period, and this report includes the proposed method for distributing profits. The Board shall place these documents at the auditor's disposal before the specified date. The General Assembly will be held within forty-five days at least. The company's Chairman, CEO and CFO must sign the documents referred to in Paragraph (1) of this Article, and a copy thereof shall be deposited at the company's main office at the disposal of the shareholders before the date set for the assembly to be held. The public within at least twenty-one days. The Chairman of the Board of Directors must provide the shareholders with the company's financial statements after signing them and the Board of Directors' report. And the auditor's report, if any, unless published in any modern technical means, before the date specified for the General Assembly (twenty-one days) at least one day, and he must also deposit these documents in accordance with what the regulations specify.

Article Forty-Two: Distribution of Dividends

The company's annual net profits are as follows: - (10%) of the net profits are set aside to form the company's contractual reserve, provided that this stop set aside when the aforementioned reserve reaches (30%) of the paid-up capital. When determining the share of net profits, the ordinary general assembly may decide creating reserves, to the extent that achieves the company's interest or ensures the distribution of fixed profits as much as possible to shareholders. And the aforementioned Assembly as well. To deduct amounts from the net profits to establish social institutions for the company's employees or to assist existing ones. Determined by the General Assembly Ordinary: The percentage





that must be distributed to shareholders from net profits after deducting reserves, if any. The company may, by Resolution of the Board of Directors distributing interim dividends on a quarterly or semi-annual basis".

Article Forty-Three: Entitlement to Dividends

The shareholder is entitled to his share in the profits in accordance with the General Assembly's Resolution issued in this regard. The Resolution shall indicate the due date and distribution date, and the eligibility shall be dividends for shareholders registered in shareholder registers at the end of the day specified for vesting. The Board of Directors must implement the General Assembly's Resolution concerning the distribution of dividends to registered shareholders within a period not exceeding fifteen (15) working days from the date of entitlement to those dividends specified in the General Assembly Resolution.

Article Forty-Four: Distribution of dividends for preferred shares

Profits for any financial year, it is not permissible to distribute profits for the following years except after paying the percentage specified in accordance with the provisions of Article (114) of the corporate system for holders of preferred shares for this year. If the company fails to pay the percentage specified in accordance with the provisions of Article Fourteen below (per cent) of the profits for three consecutive years, then a special assembly of the owners of these shares held in accordance with the provisions of Article (Eighty-ninth) of the Companies Law, to decide whether to attend the company's general assembly meetings and participate in voting, or to appoint representatives on behalf of them in the Board of Directors in proportion to the value of their shares in the capital, until the company is able to pay all priority dividends allocated to the owners.

Chapter Seven: Dissolution and Liquidation of the Company

Article Forty-Five: Company losses

If the company's losses amount to half of its capital, the Board of Directors must disclose that and the recommendations it reached regarding those losses within (Sixty) days from the date of his knowledge that this amount has been reached, and to invite the Extraordinary General Assembly to meet within (one hundred and eighty) days from the date of knowledge. Thus, to consider the continuation of the company while taking any necessary measures to address or resolve those losses.

Article Forty-Six: Liability claim

Every shareholder has the right to file a liability claim against the members of the Board of Directors if the error committed by them results in special damage provided that the





company's right to file it still exists. The shareholder must notify the company of his intention to file a lawsuit.

Article Forty-Seven: Expiration of the company

Once the company has completed its liquidation period, it will retain its legal personality to the extent necessary for liquidation, and the voluntary liquidation Resolution will be issued by the assembly. The liquidation Resolution must include the appointment of the liquidator, determine his powers and fees, the restrictions imposed on his powers, and the time period. necessary for liquidation. The period of voluntary liquidation must not exceed three years, and it may not be extended for more than that except by judicial order, and the authority of the Board of Directors ends. Management of the company upon its dissolution. However, they remain responsible for the management of the company and are considered, with respect to others, in the same ruling as liquidators until the liquidator is appointed and the Shareholders' assemblies exist during the liquidation period and their role is limited to exercising their powers that do not conflict with the powers of the liquidator.

Chapter Eight: Final Provisions

Article Forty-Eight: Final Provisions

- 1. The company is subject to the regulations in force in the Kingdom of Saudi Arabia.
- 2. Any text in this bylaw that contradicts the provisions of the Companies Law will not be taken into account, and the provisions contained in the Companies Law and everything that is not stated therein will be applied to it. A text in this bylaw to which the companies' system and its executive regulations apply.
- 3. The founders acknowledge the validity of the data and provisions included in this system and their agreement with the provisions of the company's system issued by Royal Decree (M/132) dated 1/12/1443H and its executive regulations, and that it fulfills all requirements and instructions issued by the Ministry of Commerce in accordance with the provisions of the Bylaws. The founders are responsible for all legal and financial consequences that may arise from this. The founders are also aware of the ministry's right to take action

The necessary legal procedures in the event of any violation or conflict in the provisions contained in the Bylaws.
