Bylaws of Abdulmohsen Al-Hokair Group for Tourism and Development Company (Joint Stock Company)

Chapter One: Incorporation of the Company

Article (1): Incorporation

In accordance with the provisions of the Companies Law issued by Royal Decree No. (M/132) dated 12/1/1443 AH and its implementing regulations, and this Memorandum of Association, a Saudi joint stock company is hereby incorporated as follows:

Article (2): Company Name

Abdulmobsen Al-Hokair Group for Tourism and Development Company (Joint Stock Company)

Article (3): Head Office of the Company

The head office of the company shall be in the city of Riyadh. The company may establish branches inside or outside the Kingdom by a resolution of the Board of Directors.

Article (4): Objectives of the Company

The company shall carry out and implement the following objectives:

The company shall exercise its objectives in accordance with the applicable regulations and after obtaining the necessary licenses from the competent authorities, if any.

Article (5): Term of the Company The term of the company is unlimited.

Chapter Two: Capital and Shares

Article (6): Capital

The issued capital of the company is determined at three hundred and fifteen million Saudi Riyals (315,000,000) divided into (315,000,000) registered shares of equal value, each with a value of (1) Saudi Riyal. All shares are ordinary shares issued in exchange for in-kind contributions fully paid according to a certified valuation report.



Article (7): Subscription for Shares

The shareholders have subscribed to the entire issued capital of 315,000,000 Saudi Riyals, which has been paid in full.

Article (8): Register of Shareholders

- The company shall maintain a special register of the names, nationalities, data, addresses, occupations, number of shares owned by each shareholder, share numbers, and the amount paid for them. The company may contract for the preparation of this register, which must be kept in the Kingdom.
- 2. The company shall provide the Commercial Register with the data of the register referred to in paragraph (1) of this Article and any amendments thereto within (fifteen) days from the date of registration of the company with the Commercial Register or from the date of the amendment, as the case may be.

Article (9): Trading of Shares

 The shares of the company shall be traded by registration in the Register of Shareholders, and the transfer of ownership of a share shall not be effective against the company or third parties until the date of such registration.

Article (10): Sale of Unpaid Shares

- The shareholder is obligated to pay the remaining value of the share on the specified dates. If the shareholder fails to fulfill the payment within the specified period, the Board of Directors, after notifying the shareholder via modern technology, registered mail, or any means of modern technology, may sell the share in a public auction or on the financial market, as the case may be.
- The company shall collect the amounts due to it from the proceeds of the sale, and the remainder shall be returned to the shareholder. If the proceeds of the sale are not sufficient to fulfill these amounts, the company may recover the remaining amount from all the shareholder's funds.
- 3. The enforcement of rights related to shares with unpaid balances shall be suspended upon the expiry of the specified payment deadline until they are sold or the due amount is paid according to the provision of paragraph (1) of this article. These rights include the right to receive a share of the net profits that are decided to be distributed, the right to attend meetings, and the right to vote on their resolutions. However, the shareholder in default may, until the date of sale, pay the due amount plus the expenses incurred by the company

- in this regard. In this case, the shareholder shall have the right to request the profits that are decided to be distributed.
- 4. The company shall cancel the certificate of the share sold according to the provisions of this article and shall issue a new certificate to the buyer bearing the same number. The sale shall be recorded in the shareholders' register, including the necessary information of the new owner.

Article (11): Capital Increase

- The issued capital may be increased by a resolution of the Board of Directors within the limits of the authorized capital, provided that the issued capital has been fully paid.
- 2. The Extraordinary General Assembly may resolve to increase the company's issued capital, provided that the issued capital has been fully paid. It is not required that the capital be fully paid if the unpaid portion relates to shares issued in exchange for the conversion of debt instruments or financing instruments into shares and the period specified for their conversion has not yet expired.

Article (12): Capital Reduction

- 1. The Extraordinary General Assembly may resolve to reduce the capital if it exceeds the company's needs or if the company incurs losses. In the latter case only, the capital may be reduced to less than the limit stated in Article (59) of the Companies Law. The reduction resolution shall not be issued except after reading a statement in a General Assembly, followed by the Board of Directors, stating the reasons for the reduction, the company's obligations, and the impact of the reduction on fulfilling them, provided that a report from the company's auditor is attached to this statement.
- 2. If the capital reduction is a result of exceeding the company's needs, creditors must be invited to submit their objections, if any, to the reduction at least forty-five days before the date set for the Extraordinary General Assembly meeting to decide on the reduction. The invitation shall be accompanied by a statement clarifying the amount of capital before and after the reduction, the date of the meeting, and the effective date of the reduction. If any of the creditors object to the reduction and submit their documents to the company within the aforementioned period, the company must pay their debt if it is due or provide them with sufficient guarantees to fulfill it if it is deferred.

 Equality must be observed among shareholders holding shares of the same type and class when reducing the capital

Article (13): Company's Purchase, Sale, and Mortgago of its Shares (Treasury Shares)

- 1. The company may purchase, sell, and mortgage its shares in accordance with the controls determined by the competent authority, based on the approval of the Extraordinary General Assembly and the Board of Directors. If the purpose of the company's purchase of its shares is to allocate them to the company's employees under the Employee Share Program, the Extraordinary General Assembly may authorize the Board of Directors to determine the terms of this program, including the allocation price for each share offered to employees if it is for consideration.
- The company also has the right to mortgage its ordinary or preferred shares as a guarantee for its debts in accordance with the Companies Law and the controls issued thereunder by the Capital Market Authority, based on the approval of the Ordinary General Assembly and the Board of Directors.

Chapter Three: Board of Directors Article (14): Company Management

(A) The company shall be managed by a Board of Directors consisting of (7) members, who shall be natural persons elected by the Ordinary General Assembly of Shareholders for a period not exceeding four years.

As an exception to this, the founders appointed the first Board of Directors for a

period of 4 years as follows:

(B) The method of work of the Board of Directors shall be determined as follows:

 The company shall be managed by a Board of Directors consisting of 7 members elected by the Ordinary General Assembly of Shareholders for a period not exceeding four years.

- The quorum for a meeting shall be the presence of 50% of the members of the Board of Directors.
- The legal quorum for taking decisions shall be the approval of 51% of the members. Members of the Board may delegate attendance at meetings.
- The rules for termination of membership shall be as follows:
- Membership of the Board shall terminate upon the expiry of its term or upon the expiry of the member's eligibility for it in accordance with any system or instructions in force in the Kingdom. The General Assembly may (based on a recommendation from the Board of Directors) terminate the membership of any member who is absent from attending (three) consecutive meetings or (five) separate meetings during his membership term without a legitimate excuse accepted by the Board of Directors.

Article (15): Termination or Ending of Membership

Membership of the Board shall terminate upon the expiry of its term or upon
the expiry of the member's eligibility for it in accordance with any system or
instructions in force in the Kingdom. The General Assembly may (based on a
recommendation from the Board of Directors) terminate the membership of
any member who is absent from attending (three) consecutive meetings or
(five) separate meetings during his membership term without a legitimate
excuse accepted by the Board of Directors.

Article (16): Expiry of the Board of Directors' Term, Resignation of its Members, or Vacancy of Membership

- Before the expiry of its term, the Board of Directors shall invite the Ordinary General Assembly to convene to elect a Board of Directors for a new term. If it is not possible to hold the election and the term of the current Board expires, its members shall continue to perform their duties until a Board of Directors for a new term is elected, provided that the period of continuation of the members of the expired Board shall not exceed the period specified in the Implementing Regulations of the Companies Law.
- 2. If the Chairman and members of the Board of Directors resign, they must invite the Ordinary General Assembly to convene to elect a new Board of Directors. The resignation shall not take effect until the new Board is elected, provided that the period of continuation of the resigned Board shall not exceed the period specified in the Implementing Regulations of the Companies Law.



- 3. A member of the Board of Directors may resign from membership of the Board by means of a written notice addressed to the Chairman of the Board. If the Chairman of the Board resigns, the notice must be addressed to the remaining members of the Board and the Secretary of the Board. The resignation shall take effect in both cases from the date specified in the notice.
- 4. If the Center is aware of the death or resignation of any member of the Board of Directors and this vacancy does not result in a violation of the conditions necessary for the validity of the Board meeting due to the number of its members falling below the minimum limit, the Board may (temporarily) appoint a person with experience and competence to fill the vacant position, provided that the Commercial Register is notified of this, as well as the Capital Market Authority if the company is listed on the financial market, within fifteen days from the date of appointment, and that the appointment is presented to the Ordinary General Assembly at its first meeting. The appointed member shall complete the term of his predecessor.
- 5. If the conditions necessary for the validity of the Board of Directors meeting are not met due to the number of its members falling below the minimum limit stipulated in the Companies Law or in these Articles of Association, the remaining members must invite the Ordinary General Assembly to convene within (sixty) days to elect the required number of members.

Article (17): Powers of the Board

Without prejudice to the powers vested in the General Assembly, the Board of Directors shall have the widest powers in managing the company to achieve its objectives, and it shall have the following powers and authorities:

The Board of Directors is required to obtain the General Assembly's approval when selling assets exceeding fifty percent (50%) of the total value of its assets, whether the sale is conducted through a single transaction or multiple transactions. In this case, the transaction that results in exceeding the fifty percent (50%) threshold of the

asset value is the transaction requiring the General Assembly's approval. This percentage is calculated from the date of the first transaction completed within the preceding twelve (12) months.

Within the limits of its authority, the Board of Directors may delegate one or more of its members or third parties to carry out a specific task or tasks.

Article (18): Remuneration of Board Members

- The remuneration of the Board of Directors shall consist of a percentage of net profits, benefits in kind, attendance fees for meetings, a fixed amount, or as determined by the Ordinary General Assembly.
- 2. The Board of Directors' report to the Ordinary General Assembly at its annual meeting shall include a comprehensive statement of all remuneration, attendance fees, expense allowances, and other benefits received or entitled to be received by each member of the Board of Directors during the fiscal year. It shall also include a statement of what the members of the Board received in their capacity as employees or managers, or what they received in return for technical, administrative, or consulting work. It shall also include a statement of the number of Board meetings and the number of meetings attended by each member.

Article (19): Powers of the Chairman, Deputy, Managing Director, and Secretary

The Board of Directors shall, at its first meeting, appoint a Chairman from among its members. It may also appoint a Managing Director from among its members. The Board of Directors shall, at its first meeting, appoint a Deputy Chairman from among its members.

1. The Board of Directors shall appoint a Chief Executive Officer from among its members or from outside.

The Board of Directors shall appoint a Secretary, chosen from among its members or from outside.

The Chairman of the Board of Directors may delegate, by written resolution, some of his powers to other members of the Board or to third parties to carry out a specific task or tasks. The Deputy Chairman of the Board of Directors shall replace the Chairman in his absence, in cases where the Board of Directors has a Deputy Chairman.

Article (20): Board Meetings

- The Board of Directors shall meet at least four times a year at the invitation of its Chairman. The Chairman of the Board must call a meeting of the Board whenever requested to do so in writing by any member of the Board to discuss one or more specific matters.
- The Board of Directors shall determine the place of its meetings, which may be held using modern technology.

Article (21): Board Meetings and Resolutions

- A meeting of the Board of Directors shall not be valid unless attended by at least 50% of the members, in person or by proxy.
- Resolutions of the Board of Directors shall be passed by a majority vote of the members present, in person or by proxy. In the event of a tie, the side with which the Chairman of the meeting votes shall prevail.



 A resolution of the Board of Directors shall take effect from the date of its issuance, unless it provides for its entry into force at a later time or upon the fulfillment of certain conditions.

Article (22): Issuing Board Resolutions in Urgent Matters

 The Board of Directors may issue resolutions in urgent matters by circulating them to all members for approval, unless a member requests in writing a meeting of the Board to deliberate on them. Such resolutions shall be passed by a majority vote of its members and shall be submitted to the Board at its next meeting for ratification in the minutes of that meeting.

Article (23): Board Deliberations

- The deliberations and resolutions of the Board of Directors shall be recorded in minutes, which shall be kept by the Secretary and signed by the Chairman of the meeting, the members of the Board of Directors present, and the Secretary.
- The minutes shall be kept in a special register signed by the Chairman of the Board of Directors and the Secretary.
- Modern technology may be used for signing, documenting deliberations and resolutions, and keeping minutes.

Article (24): Formation of the Audit Committee

An Audit Committee shall be formed by a resolution of the Company's Board of Directors, consisting of shareholders or others, provided that it does not include any executive members of the Board of Directors. The Audit Committee shall consist of no less than three and no more than five members, including a specialist in financial and accounting affairs. No member of the Audit Committee may serve on the audit committees of more than five joint-stock companies listed on the market at the same time.

Article (25): Quorum for Committee Meetings

A meeting of the Audit Committee shall not be valid unless attended by a majority of its members. Its resolutions shall be passed by a majority vote of those present. In the event of a tie, the side with which the Chairman of the Committee votes shall prevail.



Article (26): Powers of the Committee

The Audit Committee shall be responsible for monitoring the Company's business and shall have the right, for this purpose, to inspect its records and documents and to request any clarification or statement from members of the Board of Directors or the executive management. It may also request the Board of Directors to call a meeting of the Company's General Assembly if the Board of Directors obstructs its work or if the Company suffers serious damage or losses.

Article (27): Committee Reports

The Audit Committee shall review the Company's financial statements, reports, and notes submitted by the external auditor and shall express its comments thereon, if any. It shall also prepare a report on its opinion regarding the adequacy of the Company's internal control system and on any other work it has carried out within the scope of its powers. The Board of Directors shall deposit sufficient copies of this report at the Company's head office at least 21 days prior to the date of the General Assembly meeting to provide a copy to any shareholder who so requests. The report shall be read during the General Assembly meeting.

Chapter Four: Shareholders' Meetings

Article (28): Meeting of the General Assembly of Shareholders

- The meeting of the General Assembly of Shareholders shall be chaired by the Chairman of the Board of Directors or, in his absence, by his Deputy, or by a member of the Board of Directors delegated by the Board in the absence of both. If this is not possible, the General Assembly shall be chaired by a person elected by the shareholders from among the members of the Board or from outside by vote.
- Each shareholder shall have the right to attend the General Assembly meeting and may be represented there by another person who is not a member of the Board of Directors.
- The General Assembly meeting may be held and shareholders may participate in deliberations and vote on resolutions through modern technology.

Article (29): Convening Meetings

 General and special meetings shall be convened by invitation of the Board of Directors. The Board of Directors shall convene the Ordinary General Assembly within thirty (30) days from the date of a request by the external auditor or by one or more shareholders representing at least ten percent (10%) of the Company's shares with voting rights. The external auditor may convene

- the Ordinary General Assembly if the Board of Directors does not convene it within thirty (30) days from the date of the external auditor's request.
- 2. The request referred to in paragraph (1) of this Article shall specify the matters to be voted on by the shareholders.
- The invitation to attend the meeting shall be sent at least twenty-one (21) days prior to the scheduled date, in accordance with the provisions of the Bylaws, taking into account the following:
 - a. Shareholders shall be notified by registered letters to their addresses stated in the Register of Shareholders, or the invitation shall be announced through modern technology.
 - b. A copy of the invitation and the agenda shall be sent to the Commercial Register, as well as a copy to the Capital Market Authority if the Company is listed on the financial market, on the date the invitation is announced.
- 4. The invitation to the general assembly meeting must include at least the following:
 - A) A statement of the person entitled to attend the general assembly meeting and his right to delegate whomever he chooses from among the members of the board of directors, and a statement of the shareholder's right to discuss the topics on the general assembly agenda and to ask questions and how to exercise the right to vote.
 - B) The place, date and time of the meeting.
 - C) The type of the assembly, whether it is a general or special assembly
 - D) The meeting agenda including the items on which shareholders are required to vote.

Article (30): Quorum of the Ordinary General Assembly Meeting

- A meeting of the Ordinary General Assembly shall not be valid unless attended by shareholders representing at least one-quarter of the company's shares with voting rights.
- 2. If the quorum required to hold the Ordinary General Assembly meeting is not met according to paragraph (1) of this article, a second meeting shall be called under the same conditions stipulated in Article (91) of the Companies Law within thirty (30) days following the date set for the previous meeting. However, the second meeting may be held one hour after the end of the period specified for holding the first meeting, provided that the invitation to the first

meeting states the possibility of holding that meeting. In all cases, the second meeting shall be valid regardless of the number of shares with voting rights represented therein.

Article (31): Quarum of the Extraordinary General Assembly Meeting

- A meeting of the Extraordinary General Assembly shall not be valid unless attended by shareholders representing at least half of the company's shares with voting rights.
- 2. If the quorum required to hold the Extraordinary General Assembly meeting is not met according to paragraph (1) of this article, a second meeting shall be called under the same conditions stipulated in Article (91) of the Companies Law. However, the second meeting may be held one hour after the end of the period specified for holding the first meeting, provided that the invitation to the first meeting states the possibility of holding that meeting. In all cases, the second meeting shall be valid if attended by a number of shareholders representing at least one-quarter (1/4) of the company's shares with voting rights.
- 3. If the quorum required to hold the second meeting is not met, a third meeting shall be called under the same conditions stipulated in Article (91) of the Companies Law, and the third meeting shall be valid regardless of the number of shares with voting rights represented therein.

Article (32): Voting in Assemblies

 The election of members of the Board of Directors shall be by cumulative voting. Members of the Board of Directors may not participate in voting on resolutions of the Assembly related to acts and contracts in which they have a direct or indirect interest or which involve a conflict of interest.

Article (33): Resolutions of Assemblies

- 1. Resolutions of the Ordinary General Assembly shall be passed by a majority of the voting rights represented at the meeting.
- 2. Resolutions of the Extraordinary General Assembly shall be passed by a two-thirds (2/3) majority of the voting rights represented at the meeting, unless the resolution relates to an increase or decrease in capital, an extension of the company's term, or its dissolution before the expiry of the period specified in its Articles of Association, or its merger with another company or its division into two or more companies, in which case it shall not be valid unless passed

by a three-quarters (3/4) majority of the voting rights represented at the meeting.

Article (34): Discussion in Assemblies

Each shareholder shall have the right to discuss the items listed on the agenda
of the General Assembly meeting and to direct questions thereon to the
members of the Board of Directors and the auditors. The Board of Directors
or the auditors shall answer the shareholders' questions to the extent that doing
so does not harm the company's interests. If a shareholder believes that the
answer to his question is insufficient, he may appeal to the General Assembly,
and its decision in this regard shall be final.

Article (35): Preparation of Minutes of Assemblies

1. Minutes shall be taken at the Assembly meeting, including the number of shareholders present in person or by proxy, the number of shares held by them in person or by proxy, the number of votes allocated thereto, the resolutions taken, the number of votes for or against them, and a comprehensive summary of the discussions that took place at the meeting. The minutes shall be recorded regularly after each meeting in a special register signed by the Chairman of the Assembly, the Secretary, and the vote collectors.

Article (36): Chairing Assemblies and Preparing Minutes

The Chairman of the Board of Directors shall chair the General Assembly meeting of shareholders, or his deputy in his absence, or a member of the Board of Directors delegated by the Board in the absence of both. If this is not possible, the General Assembly meeting shall be chaired by a person delegated by the shareholders from among the members of the Board or others by voting. Minutes shall be taken at the Assembly meeting, including the number of shareholders present or represented, the number of shares held by them in person or by proxy, the number of votes allocated thereto, the resolutions taken, the number of votes for or against them, and a comprehensive summary of the discussions that took place at the meeting. The minutes shall be recorded regularly after each meeting in a special register signed by the Chairman of the Assembly, the Secretary, and the vote collectors.

Article (37): Attendance at Assemblies

 Every subscriber, regardless of the number of shares he holds, shall have the right to attend the General Assemblies of the company, and may delegate

- another person who is not a member of the Board of Directors or an employee of the company to attend the General Assembly on his behalf.
- Meetings of the General Assemblies of shareholders may be held and shareholders may participate in their deliberations and vote on their resolutions by modern technological means, according to the regulations issued by the Capital Market Authority in this regard.

Article (38): Constituent Assemblies

The General Assembly, validly constituted, shall represent all shareholders, and may not be held except in the city where the company's head office is located. Every subscriber, regardless of the number of shares he holds, shall have the right to attend the Constituent Assembly in person or by proxy for other subscribers. Every shareholder shall have the right to attend the General Assembly, and a shareholder may delegate another shareholder who is not a member of the Board of Directors or an employee of the company to attend the General Assembly.

Article (39): Powers of the Constituent Assembly

- To verify the subscription of all capital, and payment in accordance with the provisions of the Companies Law of the minimum capital and the amount due of the value of the shares.
- To draft the final text of the company's Articles of Association, but it may not make substantial amendments to the Articles of Association submitted to it except with the approval of all subscribers represented therein.
- To appoint the members of the first Board of Directors for a period not exceeding five years, and the first auditors if they have not been appointed in the company's Memorandum of Association or Articles of Association.
- 4. To deliberate on the founders' report on the work and expenses required for the establishment.
- 5. To consider the ratification of the value of in-kind contributions.

The attendance of a number of subscribers representing at least half of the capital shall be required for its validity, and each subscriber shall have one vote in its meetings for each share subscribed to or represented by him.

Article (40): Powers of the Ordinary General Assembly

Except for matters within the competence of the Extraordinary General Assembly, the Ordinary General Assembly shall have jurisdiction over all matters relating to the company and shall meet at least once a year within the six months following the end

of the company's fiscal year. Other Ordinary Assemblies may be convened whenever the need arises.

Article (41): Powers of the Extraordinary General Assembly

The Extraordinary General Assembly shall have the power to amend the company's Articles of Association, except for provisions that are prohibited from being amended by law. It may also issue resolutions on matters that fall within the competence of the Ordinary General Assembly, under the same conditions and procedures prescribed for the Ordinary General Assembly.

Article (42): Attendance Register of Assemblies

Shareholders wishing to attend the General Assembly or a Special Assembly shall register their names at the company's head office or at the meeting place before the time set for the meeting.

Article (43): Resolutions of Assemblies

Resolutions in the Constituent Assembly shall be passed by an absolute majority of the shares represented therein. Resolutions of the Ordinary General Assembly shall be passed by an absolute majority of the shares represented at the meeting. Resolutions of the Extraordinary General Assembly shall be passed by a two-thirds majority of the shares represented at the meeting, unless the resolution pertains to increasing or decreasing the capital, extending the company's term, dissolving it before the expiry of the period specified in its Articles of Association, or merging it with another company, in which case the resolution shall not be valid unless passed by a three-quarters majority of the shares represented at the meeting.

Chapter Five: Auditors

Article (44): Appointment of Auditors

The company shall have one or more auditors from among the auditors licensed to practice in the Kingdom. The General Assembly shall annually appoint the auditor(s), determine their fees, term of office, and scope of work. The General Assembly may dismiss the auditor(s) without prejudice to their right to compensation for any damages incurred, if any.

Article (45): Powers of Auditors

The auditor(s) shall have the right at any time to inspect the company's books, records, and other documents. They may also request data and clarifications deemed necessary to verify the company's assets, liabilities, and other matters within the

scope of their work. The Chairman of the Board of Directors shall enable the auditor(s) to perform their duties. If the auditor(s) encounter any difficulties in this regard, they shall record such difficulties in a report submitted to the Board of Directors. If the Board fails to facilitate the auditor(s) work, the auditor(s) shall request the Board of Directors to convene an Ordinary General Assembly meeting to address the matter.

Chapter Six: Company Finances and Profit Distribution Article (46):

- The company's fiscal year shall be twelve Gregorian months, commencing on January 1st and ending on December 31st.
- A separate balance sheet shall be prepared for the transitional period resulting from any amendment to the fiscal year.

Article (47): Financial Documents

- 1. At the end of each fiscal year, the Board of Directors shall prepare the company's financial statements and a report on its activities and financial position for the concluded fiscal year. This report shall include the proposed method for profit distribution. The Board shall make these documents available to the auditor(s), if any, at least forty-five days prior to the scheduled date of the annual Ordinary General Assembly meeting.
- The Chairman of the Board of Directors, the Chief Executive Officer, and the Chief Financial Officer, if any, shall sign the documents referred to in paragraph (1) of this Article. Copies thereof shall be deposited at the company's principal office and made available to the shareholders.
- 3. The Chairman of the Board of Directors shall provide the shareholders with the signed financial statements, the Board of Directors' report, and the auditor(s)' report, if any, unless published through modern technological means, at least twenty-one days prior to the scheduled date of the annual Ordinary General Assembly meeting. The Chairman shall also disclose these documents in accordance with the provisions of the Implementing Regulations of the Companies Law.

Article (48): Formation of Reserves

When determining the share of net profits, the Ordinary General Assembly
may decide to form reserves to the extent that serves the company's interests
or ensures the distribution of stable dividends to the shareholders, as far as

- possible. The aforementioned Assembly may also deduct amounts from net profits to achieve social purposes for the company's employees.
- The General Assembly shall determine the percentage of net profits to be distributed to the shareholders after deducting reserves, if any.

Article (49): Profit Distribution

- 10% of the net profits shall be allocated to form a statutory reserve. The Ordinary General Assembly may decide to discontinue this allocation once the aforementioned reserve reaches 30% of the paid-up capital.
- 2. Based on the Board of Directors' proposal, the Ordinary General Assembly may allocate 10% of the net profits to form a general reserve at its discretion. The Ordinary General Assembly may decide to form other reserves to the extent that serves the company's interests or ensures the distribution of stable dividends to the shareholders, as far as possible. The aforementioned Assembly may also deduct amounts from net profits to establish social institutions for the company's employees or to support existing institutions of this nature.
- From the remaining balance, a percentage representing at least 1% of the company's paid-up capital shall be distributed to the shareholders.
- 4. The company may distribute interim dividends to its shareholders on a semiannual or quarterly basis, in accordance with the regulations issued by the Capital Market Authority, based on an authorization issued by the Ordinary General Assembly to the Board of Directors to distribute interim dividends, which shall be renewed annually.
- Zakat and tax regulations shall be applied in accordance with the applicable regulations in the Kingdom of Saudi Arabia.
- The General Assembly shall approve the profits proposed by the Board and the method of their distribution.
- 7. Cash dividends approved for distribution to shareholders shall be credited to their accounts linked to their investment portfolios. Granted shares shall be credited to the shareholders' investment portfolios after the announcement is made on the market website and the company's website.

Article (50): Dividend Distribution for Preferred Shares

 If no dividends are distributed for any fiscal year, no dividends shall be distributed for subsequent years until the percentage specified in Article (114) of the Companies Law is paid to the holders of preferred shares for that year.



2. If the company fails to pay the percentage specified in Article (114) of the Companies Law from the profits for three consecutive years, the special assembly of the holders of these shares, convened in accordance with the provisions of Article (89) of the Companies Law, may decide either to attend the company's General Assembly meetings and participate in voting, or to appoint representatives on the Board of Directors in proportion to the value of their shares in the capital, until the company is able to pay all priority dividends allocated to the holders of these shares for the previous years.

Article (51): Company Losses

- 1. If a joint-stock company's losses reach half of its paid-up capital at any time during the fiscal year, any company official or auditor, upon becoming aware of this, shall immediately inform the Chairman of the Board of Directors. The Chairman shall immediately inform the Board members. Within fifteen days of becoming aware of the losses, the Board of Directors shall convene an Extraordinary General Assembly meeting within forty-five days from the date of becoming aware of the losses to decide either to increase or decrease the company's capital in accordance with the provisions of the Companies Law to the extent that the losses fall below half of the paid-up capital, or to dissolve the company before the expiry of the term specified in the Companies Law.
- 2. The company shall be deemed dissolved by operation of law if the General Assembly does not meet within the period specified in paragraph (1) of this Article, or if it meets and fails to issue a resolution on the matter, or if it decides to increase the capital in accordance with the provisions of this Article and the entire capital increase is not subscribed within ninety days from the date of the Assembly's resolution to increase the capital.

Chapter Seven: Company Dissolution Article (52): Dissolution of the Company

1. The company shall be dissolved for any of the reasons for dissolution stipulated in Article (143) of the Companies Law. Upon dissolution, the company shall enter the liquidation phase in accordance with the provisions of Chapter Iwelve of the Companies Law. If the company is dissolved and its assets are insufficient to settle its debts, or if it is financially distressed according to the Bankruptcy Law, it shall apply to the competent judicial authority to commence any of the liquidation procedures under the Bankruptcy Law.

Chapter Eight: Final Provisions Article (53): Final Provisions

- The company shall be subject to the applicable laws and regulations in the Kingdom of Saudi Arabia.
- Any provision in these Bylaws that contradicts the provisions of the Companies Law shall be deemed null and void, and the relevant provisions of the Companies Law shall apply. Any matter not addressed in these Bylaws shall be governed by the Companies Law and its Implementing Regulations.
- 3. The founders acknowledge the accuracy of the information and provisions contained in these Bylaws and their conformity with the provisions of the Companies Law issued by Royal Decree No. (M/132) dated 1/12/1443 AH and its Implementing Regulations, as well as their compliance with all requirements and instructions issued by the Ministry of Commerce in accordance with the provisions of the Law. The founders shall bear all legal and financial liabilities that may arise therefrom. The founders are also aware of the Ministry's right to take necessary legal action in the event of any violation or conflict with the provisions contained in these Bylaws.

Article (54): Publication

 These Bylaws shall be deposited and published in accordance with the provisions of the Companies Law and its Implementing Regulations.

Article (55): Liability Claim

Every shareholder shall have the right to file a liability claim against the members of the Board of Directors on behalf of the company if an error committed by them causes him specific harm. The shareholder may not file the aforementioned claim unless the company's right to file it is still valid. The shareholder must notify the company of his intention to file the claim.
