Article Eleven: Council Members' Remuneration

- 1- The Board of Directors' remuneration shall consist of a percentage of net profits or what is determined by the Ordinary General Assembly.
- 2- The Board of Directors' report to the Ordinary General Assembly at its annual meeting must include a comprehensive statement of all the bonuses, meeting attendance allowances, expense allowances, and other benefits that each member of the Board of Directors received or was entitled to receive during the fiscal year. It must also include a statement of what the members of the Board received in their capacity as employees or administrators or what they received in exchange for technical, administrative, or consulting work, and it must also include a statement of the number of Board sessions and the number of sessions attended by each member.

Article Twelve: Powers of the President, Vice President, Managing Director and Secretary

The Board of Directors shall appoint, at its first meeting, a Chairman of the Board from among its members, and may appoint from among its members a Managing Director or Deputy Chairman of the Board of Directors.

1- The Board of Directors shall appoint a CEO from among its members or from others.

The General Assembly shall determine the percentage that must be distributed to shareholders from the net profits after deducting reserves, if any. - The shareholder shall be entitled to his share of the profits in accordance with the General Assembly's decision issued in this regard. The decision shall specify the due date and the distribution date, and the right to profits shall be for the shareholders registered in the shareholders' records at the end of the day specified for due date. The regulations shall specify the maximum period during which the Board of Directors must implement the General Assembly's decision regarding the distribution of profits to shareholders:
