Saudi Stock Exchange (Tadawul) - Annual Statistical 2020

Market Summary

Total Value of Shares Traded reached SAR 2,087.80 billion, 76.69 million Transactions were executed during the year 2020

At the end of the year 2020 Tadawul All Share Index (TASI) closed at a level of **8,689.53** points compared to **8,389.23** points for the previous year, gained **300.30** points (**3.58%**). The highest close level for the index (TASI) during the year (2020) was **8,760.08** points as on 30th of December.

The total **Market Capitalization** at the end of the year 2020 reached SAR **9,101.81** billion (US\$ **2,427.15** billion), increased by **0.85%** compared to the end of the previous year.

The total **Value of Shares Traded** for the year 2020 reached SAR **2,087.80** billion (US\$ **556.75** billion) compared to SAR **880.14** billion (US\$ **234.70** billion) for the previous year, increased by **137.21%**.

The total number of **Transactions** executed during the year 2020 reached **76.69** million compared to **28.40** million trades for the previous year, increased by **170.06%**.

The **Volume Traded*** for the year 2020 reached **79.32** billion shares compared to **33.85** billion shares traded during the previous year, increased by **134.29%**.

* Historical prices & volume traded data are adjusted to account for all corporate actions during the year. Number of trading days during 2020 were 251 days, against 250 trading days during 2019.

The **Daily Average Number of Transactions** executed during the year 2020 reached **305.52** thousand trades compared to **113.58** thousand trades during the previous year, increased by **169.00%**.

The **Daily Average Value of Shares Traded** during the year 2020 reached SAR **8,317.93** million compared to SAR **3,520.56** million for the previous year, increased by **136.27%**.

The **Daily Average Volume Traded** during the year 2020 reached **316.03** million shares compared to **135.43** million shares traded during the previous year, increased by **133.35%**.

Industry Groups Activities:

In term of number of **transactions** during the year 2020, the Materials industry group was the most active industry group with **16.07** million trades that represent **20.96%** of the total trades during the year, followed by the Insurance industry group with **9.31** million trades that represent **12.14%** and the Food & Beverages industry group with **6.40** million trades that represent **8.36%** of the total trades executed during the year 2020.

Materials industry group led the market in term of **value of shares traded** during the year 2020 amounting to SAR **612.16** billion that represent **29.32%** of the total value traded, followed by the Banks industry group with SAR **247.75** billion that represent **11.87%** and Insurance industry group SAR **185.04** billion or **8.86%** of the total value traded during the year 2020.

In term of **volume traded (adjusted)**, Materials industry group was the most active industry group during the year 2020, the number of shares traded for the industry group reached **18.56** billion shares that represent **23.40%** of the total volume traded during the year, followed by the Banks industry group with a volume of **10.09** billion shares that represent **12.73%** and Real Estate Mgmt & Dev't industry group with **10.08** billion volume traded or **12.72%** of the total shares traded during the year 2020.

Stocks Activities:

With respect to stocks activities during the year 2020, SAUDI ARAMCO led the market in term of number of **transactions** with **2,051.64** thousand trades, followed by DAR ALARKAN and ALINMA with **1,767.13** and **1,703.75** thousand transactions respectively.

SABIC led the market in term of **value of shares traded** during the year 2020 and has posted a value of SAR **300.32** billion. The two other most active stocks were ALRAJHI and SAUDI ARAMCO that posted a value of SAR **83.51** billion and SAR **66.39** billion respectively.

In term of **Volume traded** during the year 2020, DAR ALARKAN topped the list with **6.45** billion shares traded during the year, followed by ALINMA and SABIC with a volume of **4.06** and **2.58** billion shares respectively.

Initial Public Offerings (IPOs) Summary - 2020

Three companies/funds offered parts of its shares to public (IPOs) during the year 2020. At the end of the year the total number of listed companies reached **203**.

The total offered value reached SAR **5.25** billion and **102.54** million shares/units were offered for all IPOs during the year 2020.

At the end of the year 2020 the market capitalization of all IPOs reached SAR **53.73** billion that represent **0.59%** of the total market capitalization.

Saudi Arabian Oil Co (Saudi Aramco) Announces Purchase of 70% Stake in Saudi Basic Industries Corporation (SABIC) from the Public Investment Fund (PIF), the sovereign wealth Fund of Saudi Arabia

Following the receipt of all necessary regulatory clearances in all pre-closing notification jurisdictions, on June 16, 2020, Saudi Aramco completed its acquisition of a 70% stake in SABIC from PIF.

The purchase price paid by Saudi Aramco for PIF's 70% stake in SABIC is a sum of SAR 259.125 billion (US\$ 69.1 billion). This equates to SAR 123.39 price per share.

Tadawul Announces the Launch Date of the Derivatives Market

The Saudi Stock Exchange (Tadawul) announces that the launch date of the Derivatives Market will be on Sunday, 30 August 2020. This will mark the beginning of trading in the Saudi Futures 30 (SF30) Index Futures Contract, Saudi Arabia's first exchange-traded derivatives product.

The launch of The Derivatives Market is a significant step to further advance the Saudi capital market, providing investors with a full and diversified range of investment products and services. The SF30 Index Futures Contract is based on the MSCI Tadawul 30 (MT30) Index. The SF30 will provide investors with hedging tools to more effectively manage risk and will deliver expanded opportunities to gain exposure to the Saudi capital market.

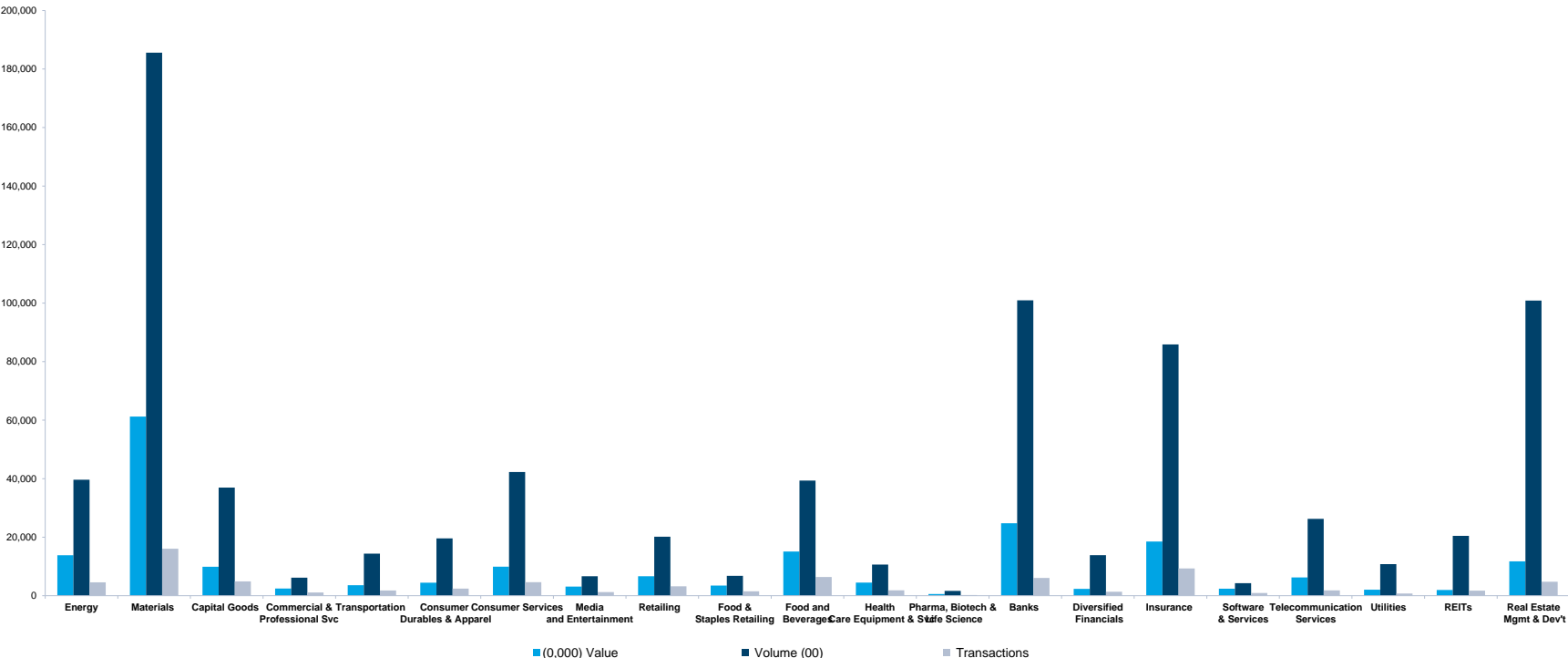

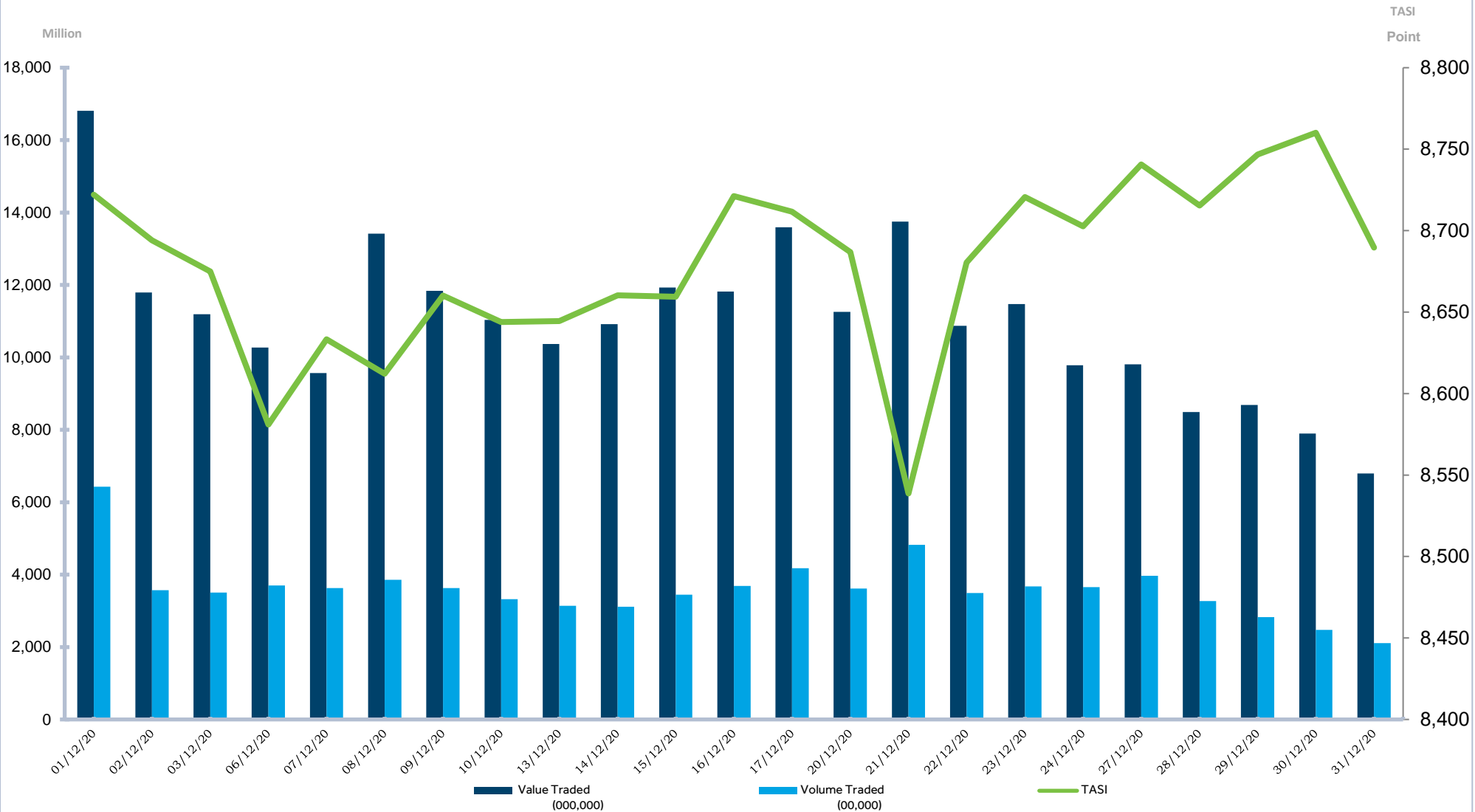

TASI - Value and Volume Traded - December 2020



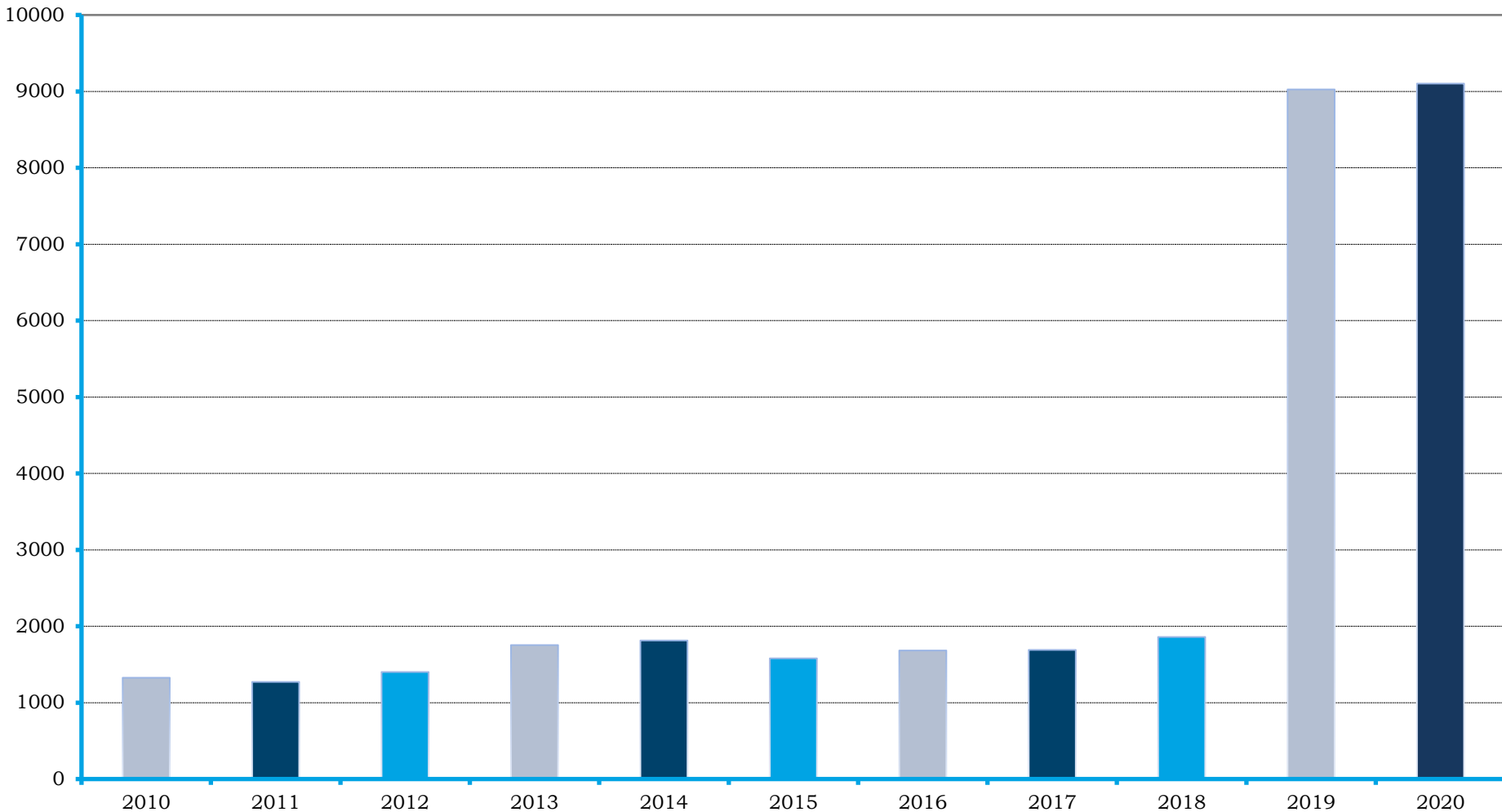
Tadawul All Share Index (TASI) - 2020

Market Capitalization 2010 - 2020 (SAR bn)

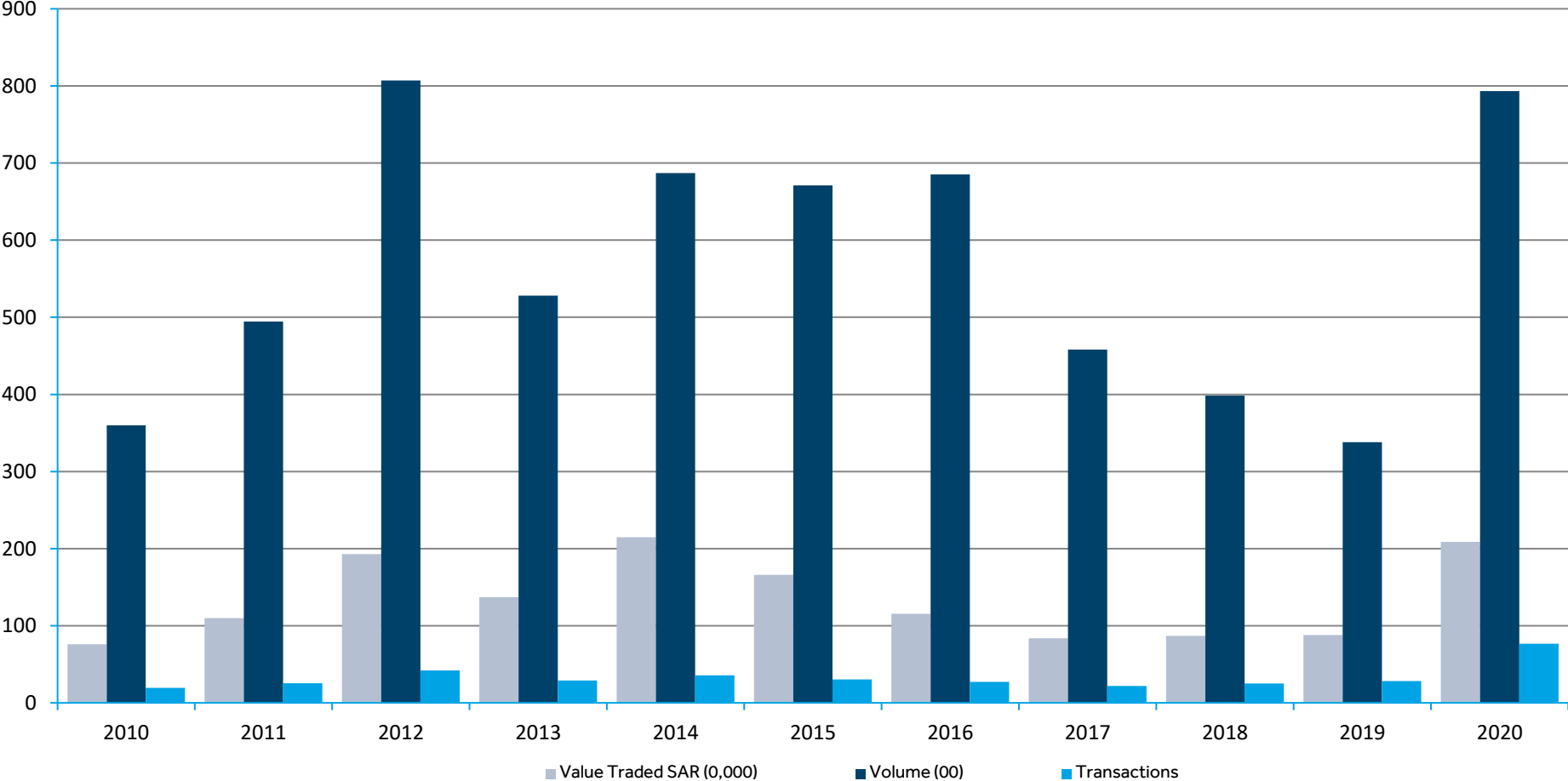

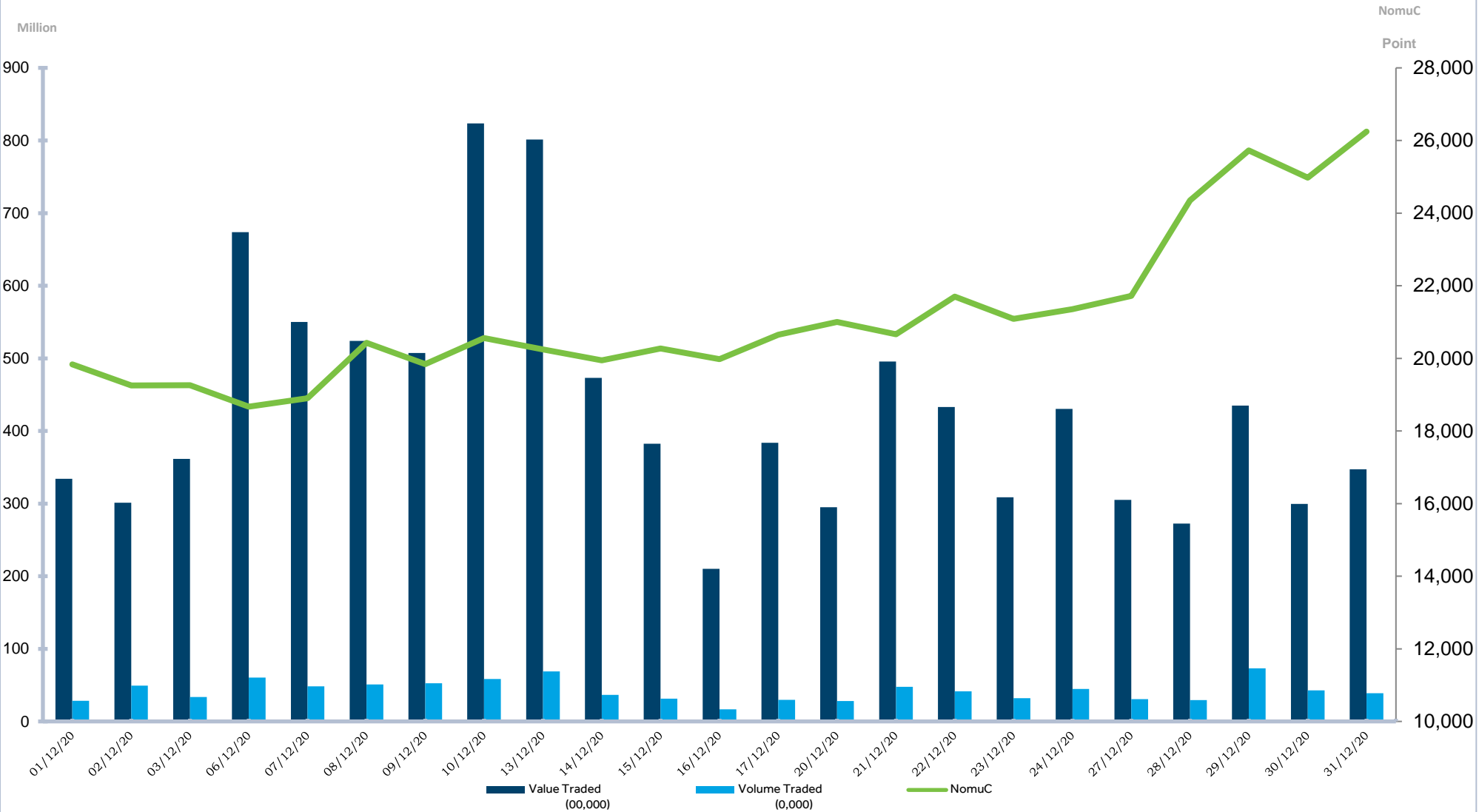

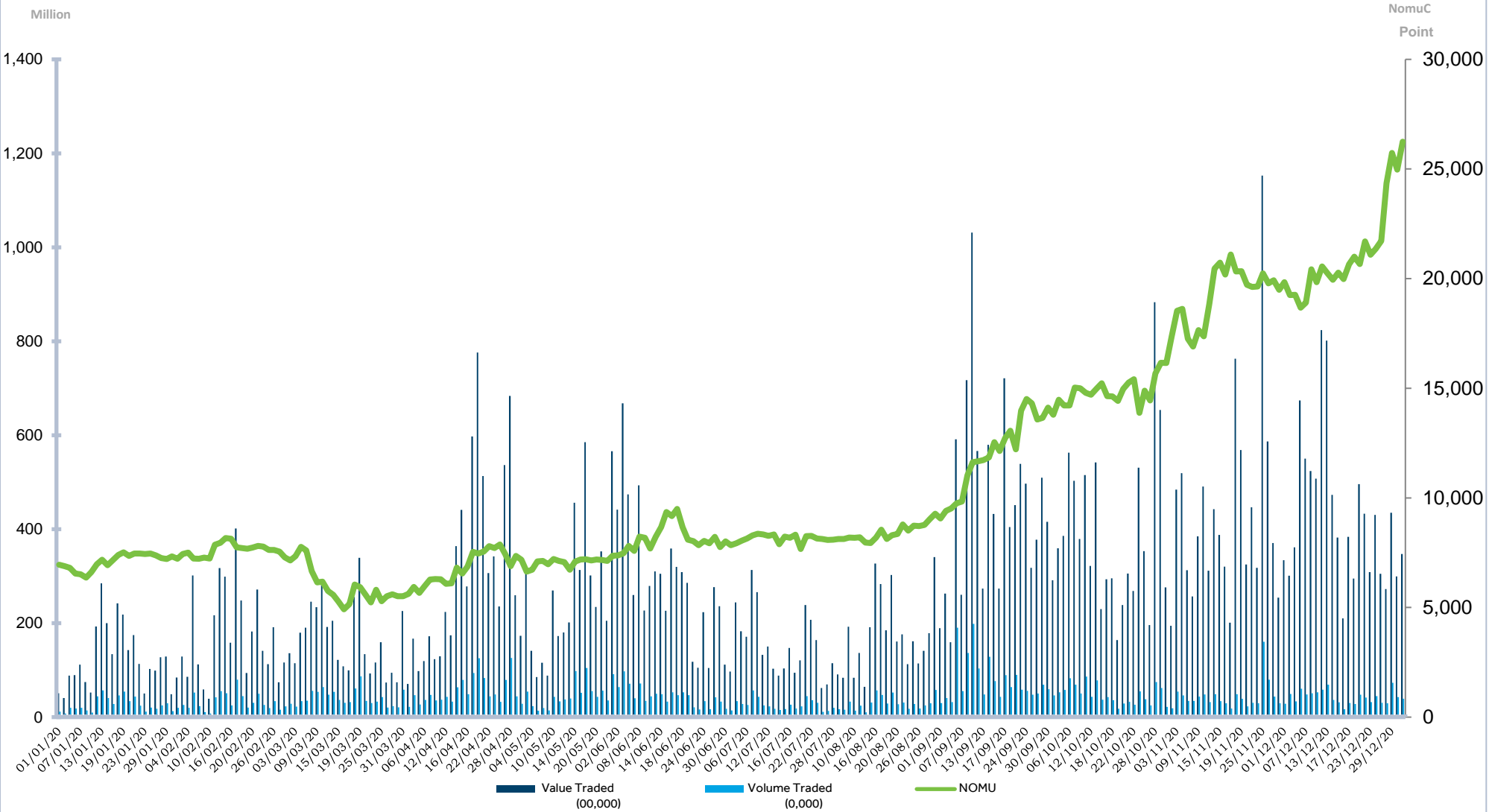

NomuC - Value and Volume Traded - December 2020



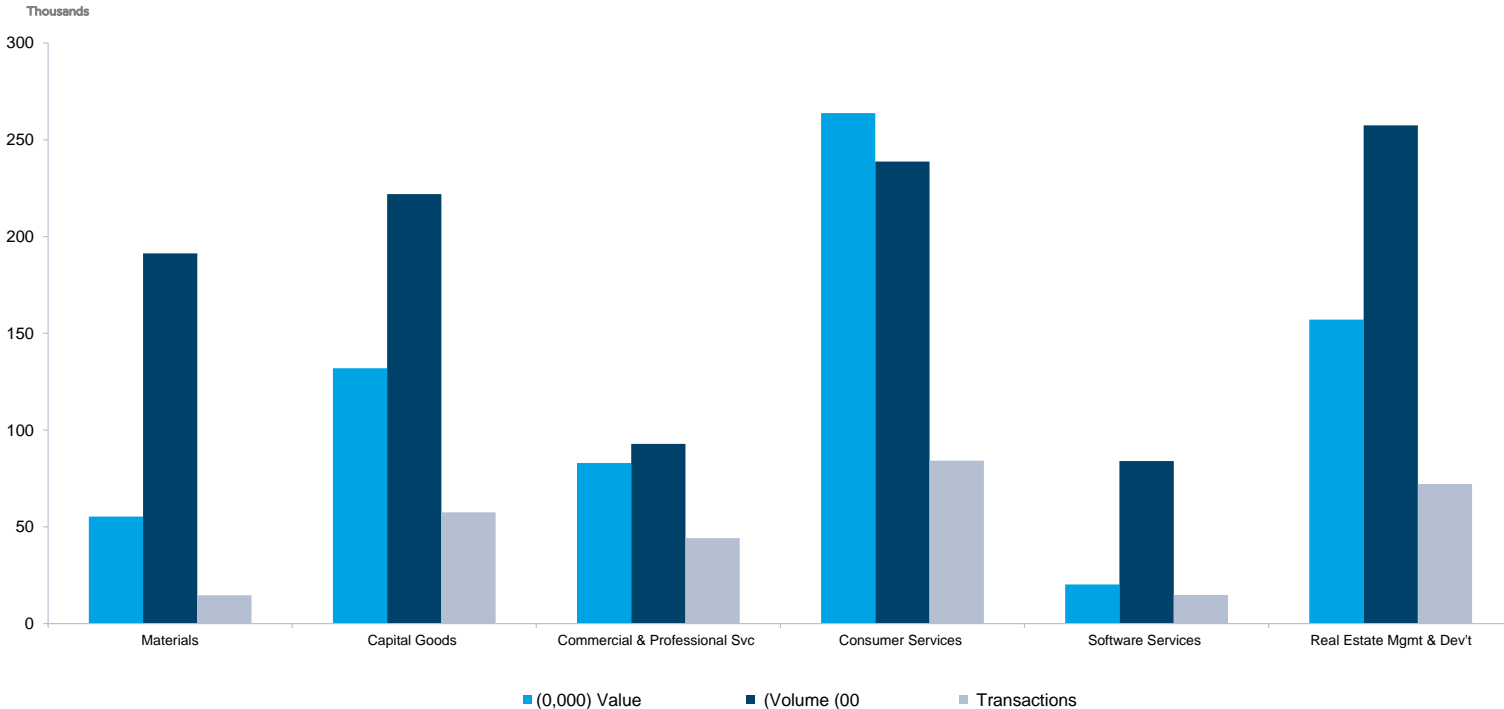
NomuC - Value and Volume Traded - 2020
