

	High Net Worth Investors (HNWIs)	HNWIs are Saudi individuals who have had an average portfolio size of SAR 1m (and above) for the preceding 12 months, excluding IPIs (see below).
	Individual Professional Investors (IPIs)	IPIs are Saudi individuals who have had an average portfolio size of SAR 50m (and above) for the preceding 12 months and a portfolio turnover ratio of not more than 4 times annually.
Saudi	Individual DPMs	Saudi individual investment account in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).
	Institutions	Saudi Institutions have been classified under 4 categories as defined below:
	Corporates	Saudi company with a commercial registration permitting its investment in the stock market .
	Mutual Funds	A mutual fund managed by an Authorized Person and licensed by the CMA.
	Government Related Entities (GREs)	A Government entity or a supranational authority recognized by the CMA.
	Institutional DPMs	Saudi institutional investment account in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).
	Individuals*	GCC natural person
GCC	Institutions	GCC legal person with a commercial registration certificate (corporate or mutual fund), in addition to GCC government entities.
	GCC DPMs	GCC investment account (institutional or individual) in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).
	SWAP Holders	Authorized Person with the permission to enter into SWAP agreements to transfer the economic benefits of its ownership of shares in Saudi companies listed on the Saudi Stock Exchange to its non-resident foreign clients.
	Foreign Residents & Others	Investors with valid residency permit (Iqama) and others (excluding SWAP, QFI, DPM & Strategic Investors)
Foreign	QFIs	Qualified Foreign Institutional investors registered with the CMA in accordance with the QFI Rules, to invest in shares listed on the Saudi Stock Exchange.
	Foreign DPMs	Foreign resident investment account in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).
	Strategic Investors	Foreign investors considered founders and partners of Saudi listed companies.

The total value of shares traded for the month ending 31 May 2021 amounted to SAR 158.72 billion, decreasing by 15.83% over the previous month; while total stock market capitalization reached SAR 9,655.61 billion at the end of this period. decreasing by 0.00002% over the previous month.

- The total value of shares purchased by "Saudi Investors" during this period amounted to SAR 142.22 billion representing 89.60 % of total buying activity, and sales of SAR 142.62 billion representing 89.86 % of total selling activity. Total ownership of "Saudi Investors" stood at 96.74 % of total market capitalization as of 31 May 2021, representing a decrease of 0.02 % from the previous month.
- The total value of shares purchased by "GCC Investors" during this period amounted to SAR 1.18 billion representing 0.74 % of total buying activity, and sales of SAR 2.55 billion representing 1.61% of total selling activity. Total ownership of "GCC Investors" stood at 0.53% of total market capitalization as of 31 May 2021, representing a decrease of 0.004% from the previous month.
- The total value of shares purchased by "Foreign Investors" during this period amounted to SAR 15.32 billion representing 9.65% of total buying activity, and sales of SAR 13.55 billion representing 8.54% of total selling activity. Total ownership of "Foreign Investors" stood at 2.73% of total market capitalization as of 31 May 2021, representing an increase of 0.02% from the previous month.


Monthly Report - Nomu-Parallel Market Highlights

The total value of shares traded for the month ending 31 May 2021 amounted to SAR 763.06 million, increasing by 146.65% over the previous month; while total stock market capitalization reached SAR 12.052.53 million at the end of this period, decreasing by 3.62% over the previous month.

The total value of shares purchased by "Saudi Investors" during this period amounted to SAR 688.15 million representing 90.18% of total buying activity, and sales of SAR 656.13 million representing 85.99% of total selling activity. Total ownership of "Saudi Investors" stood at 99.18% of total market capitalization as of 31 May 2021, representing an increase of 0.27% from the previous month.

- The total value of shares purchased by "GCC Investors" during this period amounted to SAR 2.61 million representing 0.34% of total buying activity, and sales of SAR 59.05 million representing 7.74% of total selling activity. Total ownership of "GCC Investors" stood at 0.36% of total market capitalization as of 31 May 2021, representing a decrease of 0.51% from the previous month.
- The total value of shares purchased by "Foreign Investors" during this period amounted to SAR 72.30 million representing 9.47% of total buying activity, and sales of SAR 47.87 million representing 6.27% of total selling activity. Total ownership of "Foreign Investors" stood at 0.46% of total market capitalization as of 31 May 2021, representing an increase of 0.24% from the previous month.
