Market Summary

Saudi Stock Exchange (Tadawul) – Annual Statistical Report - 2009

Total Value of Shares Traded reached **SR 1,264.01** billion and **36.46** million Transactions were executed during the year 2009

At the end of the year 2009 **Tadawul All Share Index (TASI)** closed at a level of 6,121.76 points compared to 4,802.99 points for the previous year, gained 1,318.77 points (27.46%). The highest close level for the index (TASI) during the year was 6,568.47 points as on 24^{th} of October.

The total **Market Capitalization** at the end of the year 2009 reached SR 1,195.51 billion (US\$ 318.80 billion), increased by 29.31% as compared to the previous year.

The total **Value of Shares Traded** for the year 2009 reached SR 1,264.01 billion (US\$ 337.07 billion) compared to SR 1,962.95 billion (US\$ 523.45 billion) for the previous year, a drop of 35.61%.

* The total number of **Shares Traded** for the year 2009 reached 57.34 billion compared to 60.82 billion shares traded during the previous year, decreasing by 5.73%.

The total number of **Transactions** executed during the year 2009 reached 36.46 million compared to 52.14 million trades for the previous year, decreasing by 30.07%

The **Daily Average Value of Shares Traded** during the year 2009 reached SR 5,056.05 million compared to SR 7,820.50 million for the previous year, a drop of 35.35%.

The **Daily Average Number of Shares Traded** (adjusted) during the year 2009 reached 229.35 million compared to 242.31 million shares for the previous year, decreasing by 5.35%.

The **Daily Average Number of Transactions** executed during the year 2009 reached 145.83 thousand compared to 207.71 thousand transactions for the previous year, decreasing by 29.79%.

Sectoral Activities:

In term of volume of shares traded, the Petrochemical Industries sector was the most active sector during the year 2009, the number of shares traded for the sector reached 10.98 billion shares that represent 19.15% of the total volume traded during the year, followed by the Banks & Financial Services sector with a volume of 8.90 billion shares or 15.52% of the total shares traded during the year and the Insurance sector with 5.58 billion shares traded 9.74% of the total shares traded during the year 2009.

The Petrochemical Industries sector also led the market in term of value of shares traded during the year 2009 amounting to SR 299.90 billion or 23.73% of the total value traded, followed by the Insurance sector SR 201.11 billion 15.91% and the Banks & Financial Services sector SR 149.42 billion or 11.82% of the total value traded.

In term of number of transactions during the year 2009, the Insurance sector was the most active sector with 8.58 million trades that represent 23.55% of the total transactions executed during the year, followed by the Petrochemical Industries sector 5.93 million trades 16.28% and the Agriculture & Food Industries sector with 3.47 million trades or 9.51% of the total transactions during the year 2009.

Stock Activities:

With respect to stocks activity during the year 2009, Sabic led the market in term of number of transactions with 1.64 million trades, followed by Alinma Bank and Ma'aden with 1.39 and 0.89 million transactions respectively.

In term of number of shares traded during the year 2009, Alinma Bank topped the list with 7.63 billion shares traded during the year, followed by Emaar E. C and Zain KSA with a volume of 3.19 and 3.00 billion shares respectively.

SABIC was the market leader in term of value of shares traded during the year 2009 and has posted a turnover of SR 143.16 billion. The two other most active stocks were Alinma Bank and Ma'aden that posted value of SR 95.77 billion and SR 38.74 billion respectively.

Initial Public Offerings (IPOs) Summary - 2009

The number of companies offered parts of its shares to public (IPOs) reached 11 during the year 2009. These were 7 companies from the Insurance sector, and 1 company from Petrochemical Industries, Retail, Telecommunication & Information Technology and Building & Construction Sectors.

The total offered value reached SR 3.882 billion and the number of shares offered for all IPOs during 2009 was 338.70 million shares.

Till to date **9** of the these companies (IPOs) were listed and traded in The Saudi Stock Exchange (Tadawul) bringing the total number of listed companies to 135.

By the end of the year 2009 the market capitalization of the listed IPOs companies reached SR 16.50 billion that represent 1.38% of the total market capitalization.

Returning of Anaam Co. Shares to the Continuous Automatic Trading



Tadawul All Share Index (TASI) - December 2009




Tadawul All Share Index (TASI) - 4th Q 2009



TAdawul All Share Index (TASI) - 2009





Market Capitalization 2000 - 2009 (SR billion)


